This is to give notice that the City of Batavia has conducted an evaluation as required by Executive Order 11988 and/or 11990. in accordance with U.S. Housing and Urban Development (HUD) regulations 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain and/or Wetlands Management, to determine the potential affect that its activity in the floodplain and/or wetland will have on the human environment for the Pearl Street Watermain Replacement Project under CDBG project number pending.

The City of Batavia proposes replacement of the aging water main along Pearl Street, from River Street to Franklin Street, in the City of Batavia, Genesee County, New York. The proposed project involves the replacement of the existing 6-inch water main with ±5,000 linear feet of 8-inch water main to eliminate that portion of the water main that is in a deteriorated condition, and to provide capacity for future demand. The project also includes the replacement of fire hydrants along Pearl Street. The project is located within mapped floodplain areas as designated by the Federal Emergency Management Agency (FEMA), but there are NO wetlands identified on the National Wetlands Inventory. There are three primary purposes for this notice. First, people who may be affected by activities in the floodplains and/or wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second. an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains and/or wetlands can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains and/or wetlands, it must inform
