The work to be performed consists principally of the furnishing of all labor and materials for:

Construction of a new 42ft span precast concrete bridge with a 75-year service life. The bridge will be widened to two 11-foot lanes and 4-foot shoulders, with an improved hydraulic opening to adequately pass the 100 year-storm. Approach roadway reconstruction will be done to allow for excavation and construction of the bridge as well as approving geometry. Medium stone streambank protection will be used to prevent erosion, and new approach guiderail and bridge railing will be installed.

The forgoing is a general outline of work only and shall not be construed as a complete description of the work to be performed under the Contract.

The project must be completed no more than 150 days after notice to proceed.

Bid envelope must have project name, bid date and bid time on envelope.

Bids must be made in writing on the forms furnished and shall be accompanied by a bid guaranty for an amount not less than five percent (5%) of the amount bid in accordance with the Instructions to Bidders. The successful Bidder will be required to furnish and pay for satisfactory Performance and Payment Bonds and provide insurance in accordance with the Instructions to Bidders.

All bids must be accompanied by a Non-Collusion Statement in order to be considered.

Orleans County is an Equal Opportunity/Affirmative Action employer.

The Disadvantaged Business Enterprise Utilization Goal for this project is 5%. The Equal Employment Opportunity goal for Minority Participation is 5.3% and the Women Participation goal is 6.9%. The Proposed DBE Commitment form must also be included with the bid.
