### NOTICE OF AMENDMENT AND RESTATEMENT OF BOND RESOLUTION

#### VILLAGE OF ELBA

NOTICE IS HEREBY GIVEN that a resolution amending and restating a prior bond resolution, a summary of which is published herewith, has been adopted by the Village Board of Trustees of the Village of Elba, in the County of Genesee, New York, on December 3, 2025, and the validity of the obligations authorized by such resolution may be hereafter contested only if:

1. (a) such obligations were authorized for an object or purpose for which the Village is not authorized to expend money, or

(b) the provisions of the law which should be complied with as of the date of publication of this notice were not substantially complied with and an action, suit or proceeding contesting such validity is commenced within 20 days after the date of such publication of this notice, or

1. such obligations were authorized in violation of the provisions of the Constitution of New York.

#### SUMMARY OF RESOLUTION AMENDING

#### AND RESTATING A PRIOR bond RESOLUTION

The following is a summary of an amending bond resolution, adopted by the Village Board of Trustees of the Village of Elba (the "Village") on December 3, 2025, that further amends and restates a bond resolution that was previously adopted by the Village Board of Trustees on March 16, 2021, amended on May 25, 2022 and further amended on August 2, 2023 (as so amended, the "Bond Resolution"). The proceeds from the sale of the obligations authorized under the bond resolution (as further amended and restated) will be used for the purpose of undertaking a certain sewer system capital improvements project with the majority of the work to be located primarily at the Village's wastewater treatment facility, such work to initially consist of the installation of an ultraviolet ("UV") disinfection system including, but not limited to, improvements to the headworks facility and flow distribution structure, the installation of new aeration blowers and equipment, the installation of a new backup generator, replacement of effluent pumps and controls within wet wells, the removal of buried fuel tank, installation of new electrical distribution gear and other electrical improvements, installation of sidewalks and asphalt, by-pass piping modifications and water service, replacement of existing sanitary sewer with the installation of new PVC pipe, manhole rehabilitation and the installation of backup generators at each sanitary sewer pump station, and other minor and ancillary improvements associated with the improvements to the wastewater treatment facility, as well as other improvements more fully identified in (or contemplated by) a revised preliminary engineering report prepared by CPL (Clark Patterson Lee), including all preliminary work and necessary equipment, materials, and labor and all preliminary costs and other improvements and costs incidental thereto and in connection with the financing thereof (collectively, the "Project"), and to increase the estimated maximum amount of the Project from \$4,414,000 to \$5,064,000, and to make other modifications to the Bond Resolution as may be consistent with law. Such amending and restating bond resolution authorizes the issuance and sale of a serial bond or bonds and a bond anticipation note or notes in anticipation of the issuance and sale of such serial bonds, in an aggregate principal amount not to exceed \$5,064,000, such amount to be offset by any federal, state, county and/or local funds received. Such resolution was adopted subject to permissive referendum, and such permissive referendum period has elapsed without the filing of a petition. The estimated maximum cost of the Project and the amount of bonds authorized were increased from \$4,414,000 to \$5,064,000 due to the receipt of higher than anticipated bids. The period of probable usefulness for such purpose is 40 years. A copy of the resolution amending and restating the prior bond resolution, as summarized herein, is available for public inspection during normal business hours at the Office of the Village Clerk, located in the Village Hall, 4 South Main Street, Elba, New York.
