They will be available at CITY HALL IN OIL CITY, 21 Seneca St., every Tuesday and Wednesday from 9AM until 3PM starting Tuesday, February 3rd and continuing through April 8th. Volunteers will be available in Franklin at the First Baptist Church, 1041 Liberty Street, every Thursday and Friday from 8AM until 3PM starting Thursday, February 6th continuing through April 11th. Volunteers will be available at the Titusville Health and Aging Center February 2nd through April 10th. Please bring all your information for 2025 plus last year's tax return for 2024. Also, bring any information about your HEALTH INSURANCE you purchased through the MARKET PLACE. Social Security cards and photo ID are REQUIRED at all sites for ALL individuals on your return. Those wanting rent/tax rebate should bring rent receipts or stamped "paid" tax receipts.
