LOCAL LAW NO. 1-2024 ADOPTING THE 2024 SALARY REVISIONS FOR ALL COUNTY OFFICERS SERVING FOR BEYOND TERM.

Section 1. LEGISLATIVE INTENT AND FINDINGS The Board of Supervisors hereby finds and determines that the salaries of County Officers serving for fixed terms of office may be changed and adjusted only by local law.

Section 2. COUNTY OFFICERS WITH FIXED TERMS The annual salaries of all Livingston County Officers serving for fixed terms are revised with the adoption of the 2024 salary schedule with the provisions established as follows:
