The Town of Leicester will hold a public hearing on July 8, 2025, 7 p.m., at Town Hall, 132 Main Street, Leicester, NY 14481 for the purpose of hearing public comments on the Town of Leicester's community development needs, and to discuss the possible submission of one or more Community Development Block Grant (CDBG) applications for the 2025 program year. The CDBG program is administered by the New York State Office of Community Renewal (OCR) and will make available to eligible local governments approximately \$40 million in funding for the 2025 program year for housing, economic development, public facilities, public infrastructure, and planning activities, with the principal purpose of benefiting low/moderate income persons.
