NOTICE OF SPECIAL MEETING OF THE QUALIFIED VOTERS OF
DANVILLE CENTRAL SCHOOL DISTRICT

NOTICE IS HEREBY GIVEN that a special meeting of the qualified voters of the Dansville Central School District shall be held at the High School Gymnasium Foyer in said District, on Tuesday, December 16, 2025, between the hours of 12:00 Noon to 8:00pm. The following proposition will be submitted for voter approval at said meeting:

PROPOSITION

Shall the following resolution be adopted to wit:

Resolved that the Board of Education of the Dansville Central School District is hereby authorized to undertake certain capital improvements consisting of construction and reconstruction of existing school buildings and facilities, site improvements and the acquisition of certain original furnishings, equipment, and apparatus and other incidental improvements required in connection therewith for such construction and school use, all at an estimated maximum aggregate cost of \$23,350,000; and to appropriate and expend from existing capital reserve funds \$4,615,000 for such costs, and that the balance of the costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments, with such tax to be offset by state aid available therefor; and, in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$18,735,000 shall be issued.

The School District, acting as lead agency to the extent necessary, if any, for this purpose under the State Environmental Quality Review Act and the applicable regulations promulgated thereunder ("SEQRA"), has completed its environmental review and, on October 28, 2025, has duly determined and found the purpose to be a type II action under SEQRA which will not have a significant impact on the environment and is not subject to any further environmental review under SEQRA.

AND NOTICE IS GIVEN that qualified military voters may apply for a military ballot by requesting an application from the District Clerk at (585) 335-4000 or mistretta@dansvillecsd.org. For a military voter to be issued a military ballot, the District Clerk must have received a valid ballot application no later than 5:00pm on November 20, 2025. In a request for a military ballot application or ballot, the military voter may indicate their preference for receiving the application or ballot by mail, facsimile transmission or email.

AND NOTICE IS GIVEN, that applications for early mail and absentee ballots shall be obtainable during school business hours from the District Clerk; completed applications must be received by the District Clerk at least seven (7) days before the vote and election if the ballot is to be mailed to the voter, or the day before the vote and election if the ballot is to be delivered personally to the voter. Early mail and absentee ballots must be received by the District Clerk not later than 5:00pm on December 16, 2025.

A list of persons to whom early mail, absentee and military ballots are issued will be available for inspection to qualified voters of the District in the office of the District Clerk on and after December 2, 2025, between the hours of 8:00am and 4:00pm on weekdays prior to the Election; and on December 16, 2025, the day set for the Election, said list will be posted at the polling place.

The District Clerk is authorized to amend or modify this notice to comply with applicable legal requirements.

The Department has prepared a draft permit and has made a tentative determination, subject to public comment or other information, to approve the renewal and modification of the Village of Geneseo Wastewater Treatment Plant's existing discharge of 1.5 million gallons per day (MGD) of treated sanitary wastewater to the Genesee River, a class C waterbody.

The following modifications to the permit are proposed:

Update sample frequencies to be consistent with TOGS 1.3.3

Add seasonal Ammonia effluent limitations and monitoring for loading

Update monthly average Phosphorus effluent limitations from seasonal to year-round

Add a 12-month rolling average effluent limitation for Mercury and updated the Mercury Minimization Program

Add a daily maximum effluent limitation for Total Copper

Update effluent monitoring for Di(2-ethylhexyl)phthalate to Bis(2-Ethylhexyl)Phthalate

Add a biennial pollutant scan

Reduce the daily maximum effluent limitation for Total Residual Chlorine

Reduce the acute Whole Effluent Toxicity (WET) action level to 0.3 and the chronic WET action level to 4.7

Add a schedule of compliance for achieving final Ammonia, Total Phosphorus (winter), Nitrite, Total Copper, and Total Residual Chlorine effluent limits

Add annual flow certification, a Total Dissolved Solids monitoring program, Stormwater No Exposure Certification, a Capacity, Management, Operation & Maintenance Program Plan (CMOM) to the Schedule of Additional Submittals
