PLEASE TAKE NOTICE, that the Livingston County Board of Supervisors adopted Local Law No. 6 - 2025 entitled "Overriding The Tax Levy Limit For Livingston County For The 2026 Fiscal Year on September 24, 2025." The text of the local law is set forth below.
LOCAL LAW NO. 6-2026 OVERRIDING THE TAX LEVY LIMIT FOR LIVINGSTON COUNTY FOR THE 2026 FISCAL YEAR
Be it enacted by the Livingston County Board of Supervisors as follows:
Section 1. Legislative Intent
The Livingston County Board of Supervisors has determined that it is important to maintain flexibility in the process of finalizing the 2026 fiscal year budget, and it may be necessary to override the limit on the amount of real property taxes that may be levied by Livingston County for the coming fiscal year 2026.
Section 2. Tax Levy Limit Override
The Livingston County Board of Supervisors is hereby authorized to override the tax levy limit for Livingston County for the 2026 fiscal year, if the Board deems it necessary for the County to adopt a budget for the 2026 fiscal year that requires a real property tax levy greater than the tax levy limit otherwise prescribed by Section 3-c of the General Municipal Law.
Section 3. Authority
This local law is adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes the Livingston County Board of Supervisors to override the tax levy limit by the adoption of a local law approved by a vote of sixty percent (60%) of the Board.
Section 4. Effective Date
This local law shall take effect immediately upon filing with the Secretary of State.

RESOLUTION DATED SEPTEMBER 10, 2025 AUTHORIZING THE EXPENDITURE OF THE SUM NOT-TO-EXCEED \$145,000 FROM THE 2025 BALANCE IN THE VEHICLE AND BOAT RESERVE FUND OF THE FIRE DISTRICT NUMBER 2 OF THE TOWN OF LIVONIA, LIVINGSTON COUNTY, NEW YORK, ALSO KNOWN AS THE LAKEVILLE FIRE DISTRICT, FOR THE PURPOSE OF PURCHASING ONE (1) QUICK ATTACK FIRE TRUCK CONSISTING OF: ONE (1) 2025 FORD F-550 CREW CAB, XL, 4X4 WITH 6.7L VALVE OHV POWER STROKE V8 TURBO DIESEL B20 ENGINE AND 10-SPEED AUTOMATIC TRANSMISSION; ONE (1) UTILITY BODY TO MOUNT ON FORD F-550 CHASSIS; ONE (1) FIRST OUT RESCUE EQUIPMENT CET SKID UNIT WITH 20 HP HONDA PUMP, 3 GALLON FUEL TANK, 400 GALLON WATER TANK, 10 GALLON DROP IN FOAM CELL, SCOTTY A&B FOAM SYSTEM, 100 FEET RUBBER HOSE, HOSE REEL, AND DISCHARGE AND INTAKE VALVES; ONE (1) CRIBBING KIT; ONE (1) TASK FORCE BLITZFIRE MONITOR PACKAGE; ONE (1) AUTOMATED EXTERNAL DEFIBRILLATOR (AED); AND ADDITIONAL FIRE HOSE AND FIREFIGHTING HAND TOOLS.

WHEREAS the Board of Fire Commissioners of Fire District Number 2 of the Town of Livonia, Livingston County, New York, also known as the Lakeville Fire District, by a duly adopted resolution has authorized the PURCHASE OF ONE (1) QUICK ATTACK FIRE TRUCK CONSISTING OF: ONE (1) 2025 FORD F-550 CREW CAB, XL, 4X4 WITH 6.7L VALVE OHV POWER STROKE V8 TURBO DIESEL B20 ENGINE AND 10-SPEED AUTOMATIC TRANSMISSION; ONE (1) UTILITY BODY TO MOUNT ON FORD F-550 CHASSIS; ONE (1) FIRST OUT RESCUE EQUIPMENT CET SKID UNIT WITH 20 HP HONDA PUMP, 3 GALLON FUEL TANK, 400 GALLON WATER TANK, 10 GALLON DROP IN FOAM CELL, SCOTTY A&B FOAM SYSTEM, 100 FEET RUBBER HOSE, HOSE REEL, AND DISCHARGE AND INTAKE VALVES; ONE (1) CRIBBING KIT; ONE (1) TASK FORCE BLITZFIRE MONITOR PACKAGE; ONE (1) AUTOMATED EXTERNAL DEFIBRILLATOR (AED); AND ADDITIONAL FIRE HOSE AND FIREFIGHTING HAND TOOLS at a total cost not-to-exceed \$145,000 to be paid from the 2025 balance in the VEHICLE AND BOAT RESERVE FUND of said Fire district:

NOW THEREFORE BE IT RESOLVED:

1. The specific object or purpose for which expenditures are to be made from the VEHICLE AND BOAT RESERVE FUND of said District pursuant to this resolution is to PURCHASE ONE (1) QUICK ATTACK FIRE TRUCK CONSISTING OF: ONE (1) 2025 FORD F-550 CREW CAB, XL, 4X4 WITH 6.7L VALVE OHV POWER STROKE V8 TURBO DIESEL B20 ENGINE AND 10-SPEED AUTOMATIC TRANSMISSION; ONE (1) UTILITY BODY TO MOUNT ON FORD F-550 CHASSIS; ONE (1) FIRST OUT RESCUE EQUIPMENT CET SKID UNIT WITH 20 HP HONDA PUMP, 3 GALLON FUEL TANK, 400 GALLON WATER TANK, 10 GALLON DROP IN FOAM CELL, SCOTTY A&B FOAM SYSTEM, 100 FEET RUBBER HOSE, HOSE REEL, AND DISCHARGE AND INTAKE VALVES; ONE (1) CRIBBING KIT; ONE (1) TASK FORCE BLITZFIRE MONITOR PACKAGE; ONE (1) AUTOMATED EXTERNAL DEFIBRILLATOR (AED); AND ADDITIONAL FIRE HOSE AND FIREFIGHTING HAND TOOLS.
2. The cost of such acquisition is not-to-exceed \$145,000. The cost is to be provided as follows:
A. By use of the sum not-to-exceed \$145,000 from the 2025 balance in the VEHICLE AND BOAT RESERVE FUND of said District.
3. The purchases shall be from Ford Motor Company, First Out Rescue Equipment, and other vendors of firefighting equipment.
4. The following determinations are hereby made:
A. The period of probable usefulness of such acquisition is twenty (20) years.
B. The subdivision of paragraph a. of Section 11.00 of the Local Finance Law which is applicable in this circumstance is subdivision "27."
5. That the Fire District Number 2 of the Town of Livonia, Livingston County, New York, also known as the Lakeville Fire District expend from the VEHICLE AND BOAT RESERVE FUND of said District the sum not-to-exceed \$145,000 to purchase said equipment in accordance with the financial plan set forth above.
6. This resolution is adopted subject to a permissive referendum in accordance with Section 6-g of the General Municipal Law of the State of New York.

PLEASE TAKE FURTHER NOTICE that such resolution shall take effect on 9/30/2025 if it is adopted unless a petition filed with the Lakeville Fire District secretary is signed and acknowledged or proved in the same manner as a deed to be recorded, by resident taxpayers of such Lakeville Fire District owning taxable real property aggregating at least one-quarter of the assessed valuation of all the taxable real property of the Lakeville Fire District as such valuations appear upon the latest completed assessment roll of the town or towns in which said Lakeville Fire District is located, protesting against such resolution and requesting that it be submitted to the qualified electors of the Lakeville Fire District affected for their approval or disapproval.
