PUBLIC NOTICE OF RESOLUTION OF THE TOWN OF LIVONIA ADOPTED SUBJECT TO PERMISSIVE REFERENDUM

PLEASE TAKE NOTICE that a Resolution was adopted by the Town Board of the Town of Livonia on January 22, 2025, by majority vote at a duly convened and noticed public meeting, subject to permissive referendum whereby the Town Board of the Town of Livonia approved a Resolution to establish the Town of Livonia Central Livonia Water District, the boundaries of which are set forth in the Resolution and in a Map, Plan and Report dated October, 2024, as filed in the Livonia Town Clerk's Office.

The Resolution also approved improvements to be made within such district, to wit: the installation of approximately 125,350 linear feet of 8-inch water main, a pump station, fire hydrants and valves. The water main will be installed along portions of Pennemite Road, Vanzandt Road, Densmore Road, South Livonia Road, Cadyville Road, Cleary Road, Price Road, Decker Road, Backus Road, Holmes Hill Road, Coe Road, Niver Road, Federal Road, Adams Road, Blank Road, Lindsley Road and Richmond Mills Road, and will serve approximately 365 residential, commercial and agricultural properties. The maximum amount proposed to be expended for the improvements above is \$14,260,000.00, of which \$8,150,000.00 is anticipated to come from a USDA-Rural Development grant and \$6,110,000.00 will be financed through a low interest USDA-Rural Development loan to be repaid over 38 years. The anticipated annual cost to the typical property located within the Town of Livonia Central Livonia Water District shall be on a benefit basis and is estimated to be \$1,078.00, which includes debt service for improvements and water usage charges based on typical consumption. The estimated one-time costs for hook-up fees are \$4,150.00 for the typical property, including installation of a service line at the costs of approximately \$30.00 per linear foot (\$30.00 average), \$650.00 LCWSA Fee (including a new water meter) and \$500.00 for well isolation and interior plumbing modifications. Such Resolution was adopted subject to permissive referendum and notice thereof is hereby provided pursuant to New York State Town Law §90; and
