RESOLUTION NO. 2024-355
A RESOLUTION AUTHORIZING THE CONSTRUCTION OF A COUNTY-WIDE BROADBAND SERVICE SYSTEM, FOR THE COUNTY OF LIVINGSTON, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$26,661,730 AND AUTHORIZING THE ISSUANCE OF UP TO \$26,549,730 SERIAL BONDS OF SAID COUNTY TO PAY PART OF THE COST THEREOF
WHEREAS, based upon a Type II Action of the Empire State Development Corporation, the purpose described herein has been determined to constitute a Public Use Project as defined under regulations of the State of New York promulgated pursuant to the State Environmental Quality Review Act which, by such definition, will not have a significant adverse impact upon the environment; and

WHEREAS, in the Working to Implement Reliable and Equitable Deployment of Broadband Act of 2022, constituting part MMM of Chapter 58 of the Laws of 2022 (the "Broadband Act"), the State Legislature found and declared that access to high-speed, reliable and affordable broadband is "essential for education, economic growth and full participation in civic life" and that the "benefits of broadband access should be available to all"; and
WHEREAS, in said Broadband Act, the General Municipal Law was amended by adding a new Section 99-y thereof authorizing any county, city, town or village to "establish, construct, and maintain broadband and related telecommunication infrastructure"; and
WHEREAS, the County of Livingston, New York (the "County") has determined to provide the availability of broadband service, as defined in the Act, to all residents of the County; and
WHEREAS, it is now desired to authorize the financing of such capital project; now, therefore,

be it
RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the Board of Supervisors of the County of Livingston, New York, as follows:
Section 1. The construction of a County-wide broadband service system, for the County of Livingston, New York, including original furnishings, equipment, machinery, apparatus, appurtenances, and other incidental improvements and expenses in connection therewith, is hereby authorized at a maximum estimated cost of \$26,661,730.
Section 2. The plan for the financing of the aforesaid maximum estimated cost is (i) by the issuance of not exceeding \$26,549,730 bonds of said County, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law, and (ii) by the application of \$112,000 cash contribution; provided, however, that to the extent that any grants-in-aid are received for such purpose, the amount of obligations to be issued pursuant to this resolution shall be reduced dollar for dollar.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is 10 years, pursuant to subdivision 109 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the bonds herein authorized will exceed five years.
Section 4. The faith and credit of said County Livingston, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said County, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the County Treasurer, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said County Treasurer, consistent with the provisions of the Local Finance Law.

Section 6. All other matters, except as provided herein relating to such bonds, including determining whether to issue such bonds having substantially level or declining annual debt service and all matters related thereto, prescribing which manual or facsimile signatures shall appear on said bonds, prescribing the method for the recording of ownership of said bonds, appointing the fiscal agent or agents for said bonds, providing for the printing and delivery of said bonds (and if said bonds are to be executed in the name of the County by the facsimile signature of the County Treasurer, providing for the manual countersignature of a fiscal agent or of a designated official of the County), the date, denominations, maturities and interest payment dates, place or places of payment, and also including the consolidation with other issues, shall be determined by the County Treasurer. Such bonds shall contain substantially the recital of validity clause provided for in section 52.00 of the Local Finance Law and shall otherwise be in such form and contain such recitals in addition to those required by section 52.00 of the Local Finance Law, as the County Treasurer shall determine.

Section 7. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150 - 2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.
Section 8. The validity of such bonds and bond anticipation notes may be contested only if:
1) Such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or
2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
3) Such obligations are authorized in violation of the provisions of the Constitution.
Section 9. This resolution, which takes effect immediately, shall be published in summary form in the Livingston County News, the official newspaper of said County designated for such purpose, together with a notice of the Clerk of the Board of Supervisors in substantially the form set forth in paragraph a of Section 81.00 of the Local Finance Law.
