NARRATIVE

Representative Haraz Ghanbari came into the station to report a solicitor at his house today. Mr. Ghanbari stated that a female came up to his house with a door hanger with information on it. Mr. Ghanbari stated his wife was home and pointed out their "No Soliciting" stickers on the window. The female replied that she was not soliciting and left the door hanger on the door. The female then left the area. Mr. Ghanbari stated that he captured the incident on his doorbell camera. Mr. Ghanbari stated the female was on her phone and appeared to have an audio recording app open. Mr. Ghanbari stated he was concerned with why the female needed to audio record by his house. As the female was leaving, she is then seen getting on her phone as she walks to her vehicle. Mr. Ghanbari was concerned that the female may have been sending the audio to someone else. Mr. Ghanbari stated he did recognize the female as Hollie Roberts. Mr. Ghanbari stated he was introduced to Ms. Roberts through work. Mr. Ghanbari stated that Ms. Roberts is the Engagement Director for Buckeyeblueprint.com and works closely with the Americans for Prosperity group. Mr. Ghanbari was able to provide me with a phone number for Ms. Roberts. I did contact Ms. Roberts and asked her about her visit to Mr. Ghanbari's residence. Ms. Roberts stated she was just in the neighborhood and was leaving the door hanger on his doorknob. Ms. Roberts stated she was confronted at the front door by Mrs. Ghanbari about soliciting and stated that Mrs. Ghanbari was rude to her through the door. When asked if she had been recording any audio while she was out, she stated she was only on a phone app for her door-to-door route passing out the flyers. Per the Perrysburg Codified Ordinance, the solicitation code only applies to those who are attempting to sell goods or services. Due to Ms. Roberts working with a non-profit and only passing out informational flyers, the solicitation code does not apply in this instance. I told Ms. Roberts that based on what I gathered she had not done anything wrong. I did contact Mr. Ghanbari and update him about my conversation with Ms. Roberts.

MVR and BWC were activated and working properly.
