**Department of Education
unveils national 'race theory'**

The U.S. Department of Education on April 19 published in the Federal Register a Proposed Rule to ensure that Critical Race Theory (CRT) becomes part of nationwide education curricula.

This less than surprising development is the first step toward hijacking civics and American history studies. President Joe Biden fired the first salvo in support of CRT when he issued an executive order in January dissolving President Trump's 1776 Commission, which sought to reject the claims of the *New York Times*' 1619 Project that America's founding is permanently tainted by its tolerance of slavery.

In a nutshell, the Education Department's rule seeks to expose the "unbearable human costs of systemic racism" and embrace "teaching and learning practices that reflect the diversity, identities, histories, contributions, and experiences of all students, and create inclusive, supportive and identity-safe learning environments."

Our comments in response to this dangerous proposed rule must be posted to the Federal Register by May 19, 2021. When comments are posted on the FR, they become public information and will be counted, not ignored. [Click here to comment](#). Please share the link. How should Americans respond? Board's Hensley: No virus vaccine school mandates

Moore school board member David Hensley detailed in a Facebook post his

views on vaccination clinics being held at Moore County High School Campuses.

As long as positive parental consent is required for our young people and HIPPA privacy protocols are followed, I have no issues with the Moore County Health Department using MC School facilities for vaccination programs.

That being said:

- Vaccination for extracurricular programs: Absent a state or federal law, I am against requiring a CV19 vaccination for participation in extracurricular activities. If the North Carolina High School Athletic Association (NCHSAA) tries to unilaterally implement a vaccine mandate, I will recommend MCS withdraw from the NCHSAA.

- Vaccine Mandate to attend a MCS: Absent a state or federal law, I am against requiring a CV19 vaccination to attend or work at Moore County Schools. We should respect the right of our students, their parents and our team members to chose what is best for themselves. Further, we must respect the privacy of their medical decision.

- Moore County Schools is not a medical provider. As stated above, I am fine with the health department using MCS facilities. If the health department wants to hang up some factual posters and pass out factual flyers to inform the public, I am fine with that as well. What I am not okay with is Moore County Schools providing any sort of flyers and/or information which appears to take a side, pro or con, on receiving the

unearned reputation as a moderate and as a competent man who could calm the chaos of the Trump years. The truth is that Biden's a *party* man, and his party is decidedly and radically left-wing these days. As for competence, well, let's just say the 78-year-old ... is not really the one running the show. We suspect it's President-in-Waiting Kamala Harris."

Nate Jackson, writing for The Patriot Post (PatriotPost.us), reviewing 100 days of the Biden Regime (April 26, 2021)

"As state legislators, we are adamantly opposed to creating a 'vaccine passport' or any other form of government-required identifications to show proof of COVID-19 vaccinations. These 'vaccine passports' raise serious privacy and legal concerns. North Carolinians should not be required to carry some sort of proof of vaccination to go about their daily lives. We have heard from countless constituents who have contacted us to express their strong opposition and grave concerns regarding the idea of requiring proof of vaccinations."

Rep. Jamie Boles, Rep. Allen McNeill, and 63 other Republican NC House members, denounced vaccine passports in an April 20, 2021 letter to Gov. Roy Cooper (D).

"If (public comments) are what is perceived as being the 'Critical Race Theory', I want you to know I would never support any of them or the CRT. After reviewing all the new Social Study standards, I did not find any of these perceptions included in the new standards and absolutely no mention of the CRT. ... The standards and objectives, approved by the State Board of Education, are not intended to be the curriculum, nor do they indicate the whole of a curriculum which will be written by a local public-school unit. When we are presented with our proposed curriculum, within the next few months, I will certainly be checking to make sure they are not included in our curriculum."

Moore County Board of Education member Ed Dennison goes on the record in a Facebook post April 22, 2021, pledging that he will not support Critical Race Theory curricula in county schools.
