Radio Log 3/9/2025 through 3/15/2025

On 03/09/2025, Deputies were dispatched to the area of Highway 19 and Highway 68 for a suspicious subject. The subject was not located and deputies departed.

On 03/09/2025, Deputies conducted a traffic stop in the 600 block of East Roosevelt Street. The driver, a 39-year-old Salem man, was released with a warning.
