NOTICE OF ADMINISTRATIVE DISSOLUTION

The Secretary of State's Office was notified by Douglas Chronister that Zhejiang Trimax International Group Corp. ("the corporation"), filing ID 2025-001820392, used his name as the incorporator of the corporation without authorization. We conducted an audit of the registered agent under Wyoming Statute § 17-28-108. As a result of this audit, we discovered that the corporation listed Mr. Chronister and his address as the contact information for the corporation. Mr. Chronister maintains that he has no connection to this corporation, and the naming of him as contact agent for the corporation has been done falsely or fraudulently. A copy of Mr. Chronister's statement detailing this concern is attached for reference.

Pursuant to Wyoming Statute § 17-16-1420(a)(vi)(B), when a corporation has provided fraudulent information or has failed to correct false information upon request of the Secretary of State on any filing with the Secretary of State under this chapter, and it is in the public interest, the Secretary "shall administratively dissolve" the corporation. Accordingly, with this Notice, the Secretary of State is commencing the process for administrative dissolution of the Corporation pursuant to Wyoming Statute § 17-16-1421(b).

Pursuant to Wyoming Statute § 17-16-1420(b), the Secretary of State has classified the Corporation as delinquent.

Pursuant to Wyoming Statute § 17-28-104, the Secretary of State may provide this notice by first-class mail or electronic means. We have elected to provide this notice to the Corporation through electronic means, and it has been sent to the email addresses on file with the Secretary of State's Office.

The Corporation has **sixty (60) days** from service of this Notice to correct the false information in their filings in a manner satisfactory to the Secretary of State's Office. Please ensure timely compliance to avoid forfeiture.

If the false information is not corrected within **sixty (60) days** from the date of service of this Notice, the Secretary of State will administratively forfeit the Corporation's articles of incorporation upon which it shall be deemed defunct.

In accordance with Wyoming Statute § 17-16-1422, after entry forfeiture, the Corporation will have two (2) years from that date to apply for reinstatement, or must pursue Judicial reinstatement pursuant to Wyoming Statute § 17-16-1423.

THIS IS THE ONLY NOTICE YOU WILL RECEIVE. IF THE FALSE INFORMATION IS NOT CORRECTED, THE CORPORATION WILL HAVE ITS ARTICLES OF INCORPORATION FORFEITED AND IT WILL BE DEEMED DEFUNCT.

1. My name is Douglas Chronister, and my address is 76 79TH ST S., St Petersburg, FL, 33707
2. I have attached a photograph of my Driver's License showing my name and address.
3. I make this Affidavit in support of my request for the dissolution of the business named "Zhejiang Trimax International Group Corp." which has been fraudulently registered using my name and address.
4. On November 23, 2025, I received a package from Legal Zoom 5021 Old Dixie Road, Forest Park, GA, 30297 indicating that they supported someone opening the "Zhejiang Trimax International Group Corp." at 1603 Capital Ave Ste 415 #447254, Cheyenne Wyoming, 82001 in my name.
5. Prior to receiving the aforementioned form, I had no knowledge of the creation or existence of the said business, "Zhejiang Trimax International Group Corp."
6. The use of my name, "Douglas Chronister," in the business name and the use of my address for the business registration have been done without my consent, knowledge, or authorization
7. The creation of the business "Zhejiang Trimax International Group Corp." using my name and address has been done fraudulently
8. I have contacted the Wyoming Secretary of State, Business Section, and have been informed that they can remove this business from their list of businesses upon my request.
9. I hereby request the immediate dissolution of "Zhejiang Trimax International Group Corp." and that the Wyoming Secretary of State, Business Section, remove this business from their list of registered businesses.

I declare under penalty of perjury under the laws of Florida that the foregoing is true and correct.
