Attached please find a copy of the *Response and Motion to Dismiss Formal Complaint (Motion)* filed by Bruce Asay, Counsel for Montana-Dakota Utilities, Co. (MDU or the Company). The Commission received this *Motion* on September 2, 2025. MDU states the Company obtained proper easements and right of way and noticed landowners along the proposed routes in April of 2024. MDU also alleges Company representatives personally communicated with you regarding the project. Ultimately, MDU states you failed to allege any violation within the Commission's jurisdiction. MDU states the transmission line project did not require Commission approval under Wyoming Statute § 37-2-205(a)(b) and Commission Rule Ch. 3 Section 21(b)(i), as the project falls within the allowed review and notice exemptions. With no violation of Wyoming statute or Commission rule, MDU requests dismissal of this complaint for failure to state a claim upon which relief can be granted and lack of Commission jurisdiction.

Please provide a written reply to the enclosed *Motion* within twenty days of your receipt of this letter. Please provide a copy of your written response to Mr. Asay concurrent with the filing of your reply with the Commission. Once received, I will place the *Motion*, and your response, on the agenda for an upcoming Open Meeting before the Commission.
