NOTICE OF ADMINISTRATIVE DISSOLUTION

On May 21, 2025, the Secretary of State's Office was notified by the Affiant that the LLC is using their name without authorization. We conducted an audit of the registered agent under Wyoming Statute § 17-28-108. As a result of this audit, we discovered that the LLC listed the Affiant and their address as the contact information for the LLC. In a sworn affidavit, maintains that they have no connection to this LLC, and the naming of them as manager or contact agent for the LLC has been done falsely or fraudulently. A copy of the Affiant's statement detailing this concern is attached for reference.

Pursuant to Wyoming Statute § 17-29-705(c)(iii)(D), when an LLC or any of its members has "provided false or fraudulent information to the registered agent, as determined by the secretary of state during or following an examination of records", and it is in the public interest, the LLC is "deemed to be transacting business within [Wyoming] without authority, to have forfeited any franchises, rights, or privileges acquired under [Wyoming] laws ... and shall be deemed defunct and to have forfeited its articles of organization or certificate of authority." Accordingly, with this Notice, the Secretary of State is commencing the process for the forfeiture of the LLC's articles of organization pursuant to Wyoming Statute § 17-29-705(c)(iii)(D).

Pursuant to W.S. 17-29-705(a), the Secretary of State may provide this notice by first-class mail or electronic means. We have elected to provide this notice to the LLC through electronic means, and it has been sent to the email address on file with the Secretary of State's Office.

The LLC has **60 (sixty) days** from the service of this Notice to correct the false information in their filings in a manner satisfactory to the Secretary of State's Office. Please ensure timely compliance to avoid forfeiture. If the false information is not corrected within **60 (sixty) days** from the date of service of this Notice, the Secretary of State will administratively forfeit the LLC's articles of organization upon which it shall be deemed defunct.

In accordance with Wyoming Statute § 17-29-707, after the entry of forfeiture, the LLC will have two years from that date to apply for reinstatement pursuant to Wyoming Statute § 17-16-1423.

THIS IS THE ONLY NOTICE YOU WILL RECEIVE. IF THE FALSE INFORMATION IS NOT CORRECTED, THE LLC WILL HAVE ITS ARTICLES OF ORGANIZATION FORFEITED AND IT WILL BE DEEMED DEFUNCT.

1. My name is Brian Knott, and my address is 3585 Kori Road, Jacksonville, FL 32257-5472

2. I have attached a photograph of my Driver's License showing my name and address.

3. I make this Affidavit in support of my request for the dissolution of the business named "Ashfield Workshop LLC", which has been fraudulently registered using my name and address.

4. In December 2024, I received a Debit Card in the mail from Bluevine Bank. Upon calling the customer service number on the card (888) 216-9619 I learned that a business account had been opened in my name by a business called "Ashfield Workshop LLC".

5. Prior to receiving the aforementioned card, I had no knowledge of the creation or existence of the said business, "Ashfield Workshop, LLC."

6. The use of my name, and the use of my address for the business registration have been done without my consent, knowledge, or authorization.

7. I believe that the creation of the business "Ashfield Workshop, LLC" using my name and address has been done fraudulently.

8. I have contacted the Wyoming Secretary of State, Business Section, and have been informed that they can remove this business from their list of businesses upon my request.

9. I hereby request the immediate dissolution of "Ashfield Workshop, LLC" and that the Wyoming Secretary of State, Business Section, remove this business from their list of registered businesses.

I declare under penalty of perjury under the laws of FLORIDA that the foregoing is true and correct.
