Attached please find a copy of the formal complaint and request for public hearing filed by Frank and Georgia Boley, customers, against Montana-Dakota Utilities Co. The complaint alleges that the Sheridan Transmission Line project was not properly communicated to affected property owners, interferes with multiple properties' viewshed, and risks devaluation of adjacent properties due to the proximity of the transmission line to property lines. Other legal, logistical, and environmental compliance concerns are noted. This complaint has been filed with the Commission because this matter has not been resolved to the satisfaction of the Complainants. I am enclosing for your review all correspondence obtained and prepared with regard to this complaint that is currently in the Commission's file.

Pursuant to Commission Rule Chapter 3, Section 11, Montana-Dakota Utilities Co. is hereby directed to provide a written answer to the enclosed formal complaint and request for hearing within twenty days of receipt.
