## NOTICE OF ADMINISTRATIVE DISSOLUTION

The Secretary of State's Office was notified by Suzanne Brier that Factory Reach LLC ("the LLC"), filing ID 2025-001637232, used her contact information to form the LLC without authorization. We conducted an audit of the registered agent under Wyoming Statute § 17-28-108. As a result of this audit, we discovered that the LLC listed Ms. Brier and her address as the contact information for the LLC. Ms. Brier maintains that she has no connection to this LLC, and the naming of her as contact agent for the LLC has been done without her consent. A copy of the statement detailing this concern is attached for reference.

Pursuant to Wyoming Statute § 17-29-705(c)(iii)(E), when an LLC or any of its members has "provided false or fraudulent information to the registered agent, as determined by the secretary of state during or following an examination of records", and it is in the public interest, the LLC is "deemed to be transacting business within [Wyoming] without authority, to have forfeited any franchises, rights or privileges acquired under [Wyoming] laws ... and shall be deemed defunct and to have forfeited its articles of organization or certificate of authority." Accordingly, with this Notice, the Secretary of State is commencing the process for the forfeiture of the LLC's articles of organization pursuant to Wyoming Statute § 17-29-705(c)(iii)(E).

Pursuant to Wyoming Statute § 17-29-705(a), the Secretary of State may provide this notice by first-class mail or electronic means. We have elected to provide this notice to the LLC through electronic means, and it has been sent to the email addresses on file with the Secretary of State's Office.

The LLC has **sixty (60) days** from service of this Notice to correct the false information in their filings in a manner satisfactory to the Secretary of State's Office. Please ensure timely compliance to avoid forfeiture.

If the false information is not corrected within **sixty (60) days** from the date of service of this Notice, the Secretary of State will administratively forfeit the LLC's articles of organization upon which it shall be deemed defunct.

**In accordance with Wyoming Statute § 17-29-707, after the entry of forfeiture, the LLC will have two years from the date of service to apply for reinstatement pursuant to Wyoming Statute § 17-16-1423.**

**THIS IS THE ONLY NOTICE YOU WILL RECEIVE. IF THE FALSE INFORMATION IS NOT CORRECTED, THE LLC WILL HAVE ITS ARTICLES OF ORGANIZATION FORFEITED AND IT WILL BE DEEMED DEFUNCT.**

AFFIDAVIT

I, Suzanne Brier, declare as follows:

1. My name is Suzanne Brier, and my address is [REDACTED]
2. I have attached a photograph of my Driver's License showing my name and address.
3. I make this Affidavit in support of my request for the administrative dissolution of the business named Factory Reach LLC, which was registered using my name and address under false pretenses and material misrepresentations.
4. I was approached regarding participation in what was represented to me as a legitimate e-commerce business venture. As part of that process, I was informed that a Wyoming limited liability company would be formed, and I agreed to proceed based on the representations made to me (which I understood to be true at the time).
5. My agreement to proceed was based on incomplete and materially misleading information. I was not fully informed as to how my personal information would be used, the true nature of the business operations, or the roles and activities of the individuals organizing and managing the entity. I did not knowingly or voluntarily consent to the formation of this entity. My consent was obtained through misrepresentation and deception. I did not provide my free and informed consent for the use of my personal information to file any business formation documents in Wyoming or any other jurisdiction.
6. I have since discovered that the representations made to me were false and that the business structure and activities associated with Factory Reach LLC were conducted under false pretenses and based on material misrepresentations. Any documents I signed or permissions I granted were obtained through misrepresentation.
7. As a result, I believe that the formation and registration of Factory Reach LLC using my name and address occurred without my fully informed consent and was induced by deception.
8. Upon discovering these misrepresentations and deceptive conduct, I reported the matter to the appropriate authorities, including the Federal Bureau of Investigation through its IC3 complaint system and the Arizona Attorney General's Office.
9. I have contacted the Wyoming Secretary of State, Business Section, and have been informed that they can remove this business from their list of registered businesses upon my request.
10. I am providing this affidavit to the Wyoming Secretary of State's Office to attest to the fraudulent nature of the formation of the business entity. I hereby request the immediate administrative dissolution of Factory Reach LLC and that the Wyoming Secretary of State, Business Section, remove this business from its list of registered businesses.

I declare under penalty of perjury under the laws of Arizona that the foregoing is true and correct.
