## NOTICE OF ADMINISTRATIVE DISSOLUTION

On September 4, 2025, the Secretary of State's Office was notified by Pamela Jacobson that Pamela Jacobson LLC ("the LLC"), filing ID 2025-001740795, is using her name without authorization. The Secretary of State's Office conducted an audit of the registered agent under Wyoming Statute § 17-28-108. As a result of this audit, we discovered that the LLC listed Ms. Jacobson and her address as the contact information for the LLC. Ms. Jacobson, in a sworn affidavit, maintains that she has no connection to his LLC, and the naming of her as a manager or contact agent for the LLC has been done falsely or fraudulently. A copy of the statement detailing this concern is attached for reference.

Pursuant to Wyoming Statute § 17-29-705(c)(iii)(E), when an LLC or any of its members has "provided false or fraudulent information to the registered agent, as determined by the Secretary of State during or following an examination of records", and it is in the public interest, the LLC is "deemed to be transacting business within [Wyoming] without authority, to have forfeited any franchises, rights or privileges acquired under [Wyoming] laws ... and shall be deemed defunct and to have forfeited its articles of organization or certificate of authority." Accordingly, with this Notice, the Secretary of State is commencing the process for the forfeiture of the LLC's articles of organization pursuant to Wyoming Statute § 17-29-705(c)(iii)(E).

Pursuant to Wyoming Statute § 17-29-705(a), the Secretary of State may provide this notice by first-class mail or electronic means. We have elected to provide this notice to the LLC through electronic means, and it has been sent to the email addresses on file with the Secretary of State's Office.

The LLC has **sixty (60) days** from service of this Notice to correct the false information in their filings in a manner satisfactory to the Secretary of State's Office. Please ensure timely compliance to avoid forfeiture.

If the false information is not corrected within **sixty (60) days** from the date of service of this Notice, the Secretary of State will administratively forfeit the LLC's articles of organization upon which it shall be deemed defunct.

**In accordance with Wyoming Statute § 17-29-707, after the entry of forfeiture, the LLC will have two years from the date of service to apply for reinstatement pursuant to Wyoming Statute § 17-16-1423.**

**THIS IS THE ONLY NOTICE YOU WILL RECEIVE. IF THE FALSE INFORMATION IS NOT CORRECTED, THE LLC WILL HAVE ITS ARTICLES OF ORGANIZATION FORFEITED AND IT WILL BE DEEMED DEFUNCT.**


