## NOTICE OF ADMINISTRATIVE DISSOLUTION

On March 21, 2025, the Secretary of State's Office was notified by Dorothy Neuf that Neuf Business Solutions LLC ("the LLC"), filing ID 2024-001569406, is using her name without authorization. We conducted an audit of the registered agent under Wyoming Statute § 17-28-108. As a result of this audit, we discovered that the LLC listed Ms. Neuf and her address as the contact information for the LLC. Ms. Neuf, in a sworn affidavit, maintains that she has no connection to this LLC, and the naming of her as manager or contact agent for the LLC has been done falsely or fraudulently. A copy of Ms. Neuf's statement detailing this concern is attached for reference.

Pursuant to Wyoming Statute § 17-29-705(c)(iii)(D), when an LLC or any of its members has "provided false or fraudulent information to the registered agent, as determined by the secretary of state during or following an examination of records", and it is in the public interest, the LLC is "deemed to be transacting business within [Wyoming] without authority, to have forfeited any franchises, rights, or privileges acquired under [Wyoming] laws ... and shall be deemed defunct and to have forfeited its articles of organization or certificate of authority." Accordingly, with this Notice, the Secretary of State is commencing the process for the forfeiture of the LLC's articles of organization pursuant to Wyoming Statute § 17-29-705(c)(iii)(D).

Pursuant to W.S. 17-29-705(a), the Secretary of State may provide this notice by first-class mail or electronic means. We have elected to provide this notice to the LLC through electronic means, and it has been sent to the email address on file with the Secretary of State's Office.

The LLC has **60 (sixty) days** from the service of this Notice to correct the false information in their filings in a manner satisfactory to the Secretary of State's Office. Please ensure timely compliance to avoid forfeiture. If the false information is not corrected within **60 (sixty) days** from the date of service of this Notice, the Secretary of State will administratively forfeit the LLC's articles of organization upon which it shall be deemed defunct.

**In accordance with Wyoming Statute § 17-29-707, after the entry of forfeiture, the LLC will have two years from that date to apply for reinstatement pursuant to Wyoming Statute § 17-16-1423.**

**THIS IS THE ONLY NOTICE YOU WILL RECEIVE. IF THE FALSE INFORMATION IS NOT CORRECTED, THE LLC WILL HAVE ITS ARTICLES OF ORGANIZATION FORFEITED AND IT WILL BE DEEMED DEFUNCT.**

**1. Personal Information**

My name is Dorothy Neuf

**2. Lack of Knowledge or Authorization**

I hereby declare under penalty of perjury that I did not form, authorize, or consent to the creation of any Limited Liability Company (LLC) under my name in the State of Wyoming.

I have never been involved in any capacity – as a member, manager, officer, trustee or representative – of any such entity.

The registration of an LLC listing me as a member was done fraudulently, without my knowledge, approval or consent.

I have never signed any documents or provided authorization for any person or entity to register an LLC under my name or using my name in any capacity, including but not limited to the name of the entity recorded as:

**3. Fraudulent Use of My Identity**

I have suffered great harm and distress as a result of this fraudulent activity and seek immediate corrective action.

**4. Request for Immediate Dissolution**

I formally request that the Wyoming Secretary of State and any relevant governing agencies take immediate action to dissolve this entity in its entirety.

I demand that my name be completely removed from all records associated with this fraudulent entity,

This entity was established under false pretenses and should not be allowed to exist with any association to me.


**5 Legal Action Consideration**


