I. The jurors for the State upon their oath present that on or about the date(s) of offense shown and in the county named above the defendant named above unlawfully, willfully and feloniously did

Did attempt to obstruct and did obstruct justice by calling [REDACTED] (17 years of age), a witness the Defendant knew was waiting to be interviewed by law enforcement, about illegal activities that allegedly occurred at a Halloween Party hosted by the Defendant. The Defendant instructed [REDACTED] to make statements to Law Enforcement that the Defendant knew to be false. The Defendant further attempted to hinder [REDACTED] cooperation with law enforcement by repeatedly asking her where she was being interviewed, where her vehicle was located, who was with her and exactly where she was at the time of the phone conversation. Minutes later, another call was placed during which the Defendant, once again, asked the witness her current location. When the witness told her, the Defendant said that she did not see her. This statement was intended to frighten and intimidate the witness and did in fact frighten the witness. This offense was committed with deceit and intent to defraud, and the defendant committed these acts in order to obstruct, impede and hinder public or legal Justice.

I. The jurors for the State upon their oath present that on or about the date(s) of offense shown and in the county named above the defendant named above unlawfully, willfully and feloniously did

obstruct justice by failing and refusing to contact law enforcement after he received reports of a First Degree Statutory Rape and by instructing witnesses not to tell anyone about the allegations of rape. The rape occurred during a Halloween party attended by the Defendant, the victim, the alleged offender and the reporting witnesses, among others. At this time, the defendant was a law enforcement officer employed with the Jackson County Sheriff's Office, and the reporting witnesses knew of the defendant's employment. The Defendant knew the alleged victim was 14 years of age and that the alleged perpetrator was more than 4 years older than the victim at the time the report was made, but the defendant did not contact law enforcement as requested and told witnesses not to tell anyone about the allegations. The offense was committed in secrecy and with malice or with deceit and intent to defraud, and the defendant committed these acts in order to obstruct, impede or hinder public justice.

II. And the jurors for the State upon their oath present that on or about the date(s) of offense shown and in the county named above the defendant named above unlawfully, willfully and feloniously did

obstruct justice by directing underage persons, who the defendant knew had consumed alcoholic beverages, to hide from law enforcement investigating allegations of illegal activity at a Halloween party the defendant and the underage persons were attending. At the time, the defendant was an off-duty law enforcement officer employed with the Jackson County Sheriff's Department. The defendant committed these acts in order to prevent the investigating officer from observing and charging violations under Chapter 18B of the North Carolina General Statutes. The offense was committed in secrecy and with malice, or with deceit and intent to defraud and the defendant committed these acts in order to obstruct, impede and hinder public or legal justice.
