The regular meeting of the Mayor and Town Council for the Town of Addis was called to order by Mayor David Toups at 6:00 p.m. on Tuesday, May 14, 2024, at the Addis Municipal Center. The pledge to the flag was led by Assistant Chief Langlois.

ROLL CALL

Present: Mayor Toups; Councilors Rusty Parrish, Bliss Bernard, Rhonda Kelley, Kevin LeBlanc, and Ray Lejeune Sr.

MINUTES

The minutes of the April 9, 2024, regular meeting were approved on a motion by Councilor Kelley; seconded by Councilor Lejeune and adopted unanimously.

ADDITIONS TO AGENDA

No additions to the agenda.

PUBLIC COMMENTS

Alonzo Goldman thanked the Public Works Department for the work they are doing in the ditch between Bird Heights & Plantation Ridge.

At the March 2024 council meeting, Paula Rhodes on behalf of Sugar Mill HOA proposed adding stop signs in multiple locations along the parkway and throughout the neighborhood to help mitigate the speeding issue. The approval to expend the funds to purchase and install the additional stop signs was made by the council pending research and recommendations from the Public Works Director and the Addis Police Department. At the April 2024 council meeting it was determined that it would be in the best interest of all to have a third-party traffic engineer review the suggestions and provide recommendations to the town based on their knowledge and expertise. Councilor Bernard advised that she did receive a response from the traffic engineer, that stated per the MUTCD – Manual on Uniform Traffic Control Devices, she would not recommend the use of stop signs for speed control. Other mitigation measures such as, do not pass signs, double striping and digital speed limit signs were discussed. Mayor Toups stated that the town would research these measures and discuss the findings at the June council meeting.

Donald Anderson, who resides in Addis Place Subdivision addressed the mayor and members of the council regarding the Town of Addis Culvert Program. Mr. Anderson stated that he did complete an application years ago and was placed on the list but was informed after

numerous follow-up calls that the program was placed on hold indefinitely. Since then, he has paid to have the culverts installed and work done himself. He is asking the town to consider reimbursing him a portion of his out-of-pocket expenses. The council asked that he provide a copy of the invoice, and they would take it under advisement after reviewing his invoice, application and additional culvert program documents.
