

Notice is hereby given, pursuant to Article IV, Section 21(D)(1) of the Louisiana Constitution, that on March 9, 2021, Entergy Louisiana, LLC ("ELL"), a public utility providing retail electric and gas service in certain parishes throughout the State of Louisiana, filed with the Louisiana Public Service Commission ("LPSC") its Application of Entergy Louisiana, LLC for Authorization to Implement Two Green Pricing Options, Rider GPO and Rider LVGPO, and Related Relief ("Application"). Through the Application, ELL seeks to make available both Rider GPO and LVGPO to provide eligible customers a voluntary option to match a portion of their monthly electricity usage with renewable energy credits ("RECs"). For Rider GPO, participants will elect to match a set proportion of their electricity usage with RECs as follows:

Option	GPO Election	Rate (\$/kWh)
Tier One Option	25%	\$0.0100 per kWh
Tier Two Option	50%	\$0.0075 per kWh
Tier Three Option	100%	\$0.0050 per kWh

Rider LVGPO will offer qualifying non-residential customers the opportunity to purchase a fixed, large volume of RECs each month to offset their electricity usage. Rider LVGPO requires at least a one-year commitment and the Monthly Rate for participation in Rider LVGPO will be the greater of: (i) \$0.0025 per kWh or (ii) the monthly average value for the S&P Global Renewable Energy Credit Index for Texas RECs, as of the current Month.

Mayor Rhodes read the Public Works Report, as prepared by Public Works Supervisor Shane Sarradet, for the month of February. There were 5.8 inches of rainfall in the month; no drainage issues; 4 SCADA alarms; street overlay project has gone out to bid; repaired sewer drain issue at 811 E. Main; no personnel incidents to report for Maintenance Department; 2 "out of compliance" test results on the Sewer Treatment Facility; south entrance Town of Brusly sign was completed on LA1 Northbound.

Regular bulk trash will be picked up the week of March 8<sup>th</sup>. The extra trash pickup will be March 26<sup>th</sup>.

#### Finance Committee:

Mayor Rhodes noted that the "Budget to Actual Comparison Report" for February was included in the meeting packets for Council Members to review.

#### Planning and Zoning Committee:

Mayor Rhodes read aloud the variance request of Joseph Richardson at 2120 Ory Dr. for non-compliance of Sec. 120-145(3), R-1 Single Family Residential, Side Depth, to reduce the side setback from 10' to 7' to build an accessory structure. Having been recommended by the Planning & Zoning Committee and having a letter of no objection from the adjoining neighbor, a motion to approve was made by Council Member Bourgeois; seconded by Council member Neisler. Mayor Rhodes opened the floor for public comments. Hearing no comments, the motion passed unanimously.

Mayor Rhodes presented the final plat of the Boulanger Subdivision on Bourgeois Street for the Council's consideration. Mayor Rhodes assured the Council that the subdivision is in compliance with the Town of Brusly Ordinance Code. After discussion, a motion to approve the final plat, contingent upon adding a table with all the distances for L1 through L16, was made by Council Member André; seconded by Council Member Daigle. Mayor Rhodes opened the floor for public comment. Hearing no comments, the motion passed unanimously.

Fund remains healthy despite the use of 2.4 million dollars in 2020 for one time projects. Much of this was surplus funds set aside in expectation of these expenditures which included \$1.25 million dollars spent for the Asphalt Road Rehabilitation Program and seven hundred thousand dollars spent for the Concrete Road Rehabilitation Program. The cost for the second phase of construction on the new water line which begins at the Intracoastal Canal and ends in Addis was 2.2 million dollars. Prior year investments from the General Fund to improve our water system has proven invaluable in light of how the parish water supply fared during the record low temperatures we just experienced in February, 2021. I sincerely appreciate the ongoing support of the Parish Council, especially their support of our recommendation to roll back 2 mills of property tax, which included one mill from the drainage department and one mil from the community centers. This was done in an effort to lessen the impact on the taxpayer from the property reassessment that occurred in 2020 along with other blows to the economy because of the pandemic.

I would like to express my sincere appreciation to my staff, directors, heads of departments and all WBR Parish Employees for the extra effort given to ensure the health and safety of our citizens during a very difficult year. I remain confident in the financial stability of West Baton Rouge Parish and I am committed to improving and preserving the quality of life enjoyed here to the best of my ability.

STATE OF THE PARISH 2020 February 25, 2021

Mr. Chairman, Council Members and Citizens of West Baton Rouge Parish:

The year 2020 was like no other in recent history for West Baton Rouge. As a parish, we faced a public health emergency, mandated quarantines, emergency food distribution and mandatory closures of schools and some business. A State of Emergency was declared seven times in 2020. Much was requiredin order to prepare for so many events in such a short time, thankfully, West Baton Rouge Parish fared well. Adjustments to standard operating procedures to include additional public safety measures have become commonplace for us. 2020 was certainly not a year for the fainthearted but we are dedicated to good parish management even in unusual and difficult times.

I am happy to report that West Baton Rouge Parish remains financially stable in spite of the challenges of 2020. A drop in revenue was expected for 2020 due to the Pandemic, however, revenues came in as budgeted and expenses came in 3.9 million dollars lower than budgeted. This was largely due to better than expected sales tax revenue. Sales tax revenue collections were approximately 8% above budgeted revenues while operating expenditures were 22% below budgeted expenditures. The Parish General the administration and all crews who came out and NAYS : worked during the recent freeze.


