

TOUPS, MAYOR OF THE TOWN OF ADDIS FOR 2019 AT A FOUR (4%) PERCENT INCREASE FROM HIS 2018 SALARY AND RICKY ANDERSON, CHIEF OF POLICE OF THE TOWN OF AD-DIS FOR 2019 AT A FOUR (4%) PERCENT INCREASE FROM HIS 2018 SALARY COM-MENCING JANUARY 1, 2019.

**WHEREAS**, the Town Council of the Town of Addis, Louisiana, is empowered with the responsibility and authority to set the salary of the Mayor for the Town of Addis and the Chief of Police for the Town of Addis, Louisiana pursuant to LSA-R.S. 33:404.1; and

WHEREAS, the Town of Addis through the Town Council, is desirous of establishing the yearly salary for the Honorable David H.
