## **Transition Timeline:**

- Current Service Provider: Republic Services will continue providing garbage service until September 30, 2024.
- New Provider: Waste Pro will start collections on October 1, 2024

## **Collection Schedule:**

- **South of the Intracoastal:** Continued Monday/Thursday Route.
- Sugar Mill Residents: will be added to the Monday/Thursday route. Starting October 1st, 2024.
- North of the Intracoastal: Continued Tuesday/Friday route. **Recycling:** Pick-up will be Parish-wide every Wednesday.
- Bulk/Out-of-Cart Pick-Up: Remains on the same weekly schedule.
