

NOW THERE BE IT ORDAINED by the West Baton Rouge Parish Council, in legal session, Chapter 6 (Alcoholic Beverages Article I (In General), Sec 6-3 (Closing Hours), Article II (Beverages Of Low Alcohol Content), Division 1 (Generally, Section 6-23 (Prohibited activities of permittees), Article III (Beverages of High Alcohol Content), Division 1 (Generally), Section 6-116 (Prohibited activities of licenses and permittees) of the Compiled Ordinances of the Parish of West Baton Rouge, Louisiana, is amended and re-enacted to read as follows:

PART II – CODE OF ORDINANCES

Chapter 6 ALCOHOLIC BEVERAGES

ARTICLE I – IN GENERAL

ARTICLE I – IN GENERAI

Sec. 6-3. – Closing Hours

(a) Class A (on premise consumption) permit

holders. Shall be closed for operation, and all premises must be vacated by the public at 2:00 a.m. until 6:00 a.m. the same day, Monday through Saturday, except as provided by section 6-2.

(1) **Exemptions.** Businesses defined as gaming facilities per section 101-1. Gaming facilities may remain open for the sale of other items permitted by law, but any sale or consumption of alcoholic beverages in such places of business during the prohibited periods set forth in Sec. 6-23 and Sec. 6-116 is expressly prohibited. During the prohibited periods, no open glasses, bottles, cans, or other containers holding alcoholic beverages shall be allowed anywhere on the licensed premises except in a locked cabinet or cupboard; provided, that those businesses which maintain separate rooms for the conduct of the business of dealing in alcoholic beverages may securely close and lock said separate rooms. Proof of the finding of any open container holding alcoholic beverages at any other place in the licensed premises during the prohibited periods shall result in a presumption that some of the contents of the container were consumed on the licensed premises on the date found; and shall further result in a presumption that the contents of the container were sold by the permit holder, his manager, agent, servant or employee on the date found. The term "open" as used in this subsection shall include, but not be restricted to, any container from which the top has at any time been removed, regardless of whether it has been replaced, and in the case of a sealed container, any container on which the seal has been broken.

(b) Class B (off premise consumption) permit holders & Class A/R (Alcohol Restaurant) permit holders. Restaurants, Grocery stores, convenience stores, drug stores, or other businesses which hold a Class B or Alcohol Restaurant License may remain open for the sale of other items permitted by law, but any sale or consumption of alcoholic beverages in such places of business during the prohibited periods set forth in Sec. 6-23 is expressly prohibited. During the prohibited periods, no open glasses, bottles, cans, or other containers holding alcoholic beverages shall be allowed anywhere on the licensed premises except in a locked cabinet or cupboard; provided, that those businesses which maintain separate rooms for the conduct of the business of dealing in alcoholic beverages may securely close and lock said separate rooms. Proof of the finding of any open container holding alcoholic beverages at any other place in the licensed premises during the prohibited periods shall result in a presumption that some of the contents of the container were consumed on the licensed premises on the date found; and shall further result in a presumption that the contents of the container were sold by the permit holder, his manager, agent, servant or employee on the date found. The term "open" as used in this subsection shall include, but not be restricted to, any container from which the top has at any time been removed, regardless of whether it has been replaced, and in the case of a sealed container, any container on which the seal has been broken.

ARTICLE II BEVERAGES OF LOW ALCOHOL CONTENT

DIVISION 1. GENERALLY

Sec. 6-23. - Prohibited activities of permittees.

No holder of a retail dealer's permit issued hereunder, and no servant, agent or employee of such permittee shall:

(1) Commit or do on the licensed premises any of the acts and things prohibited by the provisions of R.S. 26:286 and as amended thereafter or by any other applicable acts of Louisiana, all of which are made a part thereof by reference for all purposes as fully as if written herein in extenso. A violation of this section by a retail dealer or retail dealer's agent, associate, employee, representative, or servant shall be considered the retail dealer's act for purposes of suspension or revocation of the permit. Violation of this section is sufficient cause for the suspension or revocation of a permit.

(2) Sell, store, use, consume, handle, give away or otherwise dispose of any of the beverages described in section 6-21 between the hours of 1:00 a.m. and 6:00 a.m. daily and to conduct the operation of said business between the hours of 2:00 a.m. and 6:00 a.m. daily, except as provided by section 6-2. Restaurants, grocery stores, drugstores, gaming facilities (including riverboat casinos) or other business may remain open for the sale of other items permitted by law, but any sale or consumption of alcoholic beverages in such places of business during the prohibited periods set forth above is expressly prohibited. During the prohibited periods, no open glasses, bottles, cans, or other containers holding alcoholic beverages shall be allowed anywhere on the licensed premises except in a locked cabinet or cupboard; provided, that those businesses which maintain separate rooms for the conduct of the business of dealing in alcoholic beverages may securely close and lock said separate rooms. Proof of the finding of any open container holding alcoholic beverages at any other place in the licensed premises during the prohibited periods shall result in a presumption that some of the contents of the container were consumed on the licensed premises on the date found; and shall further result in a presumption that the contents of the container were sold by the permit holder, his manager, agent, servant or employee on the date found. The term "open" as used in this subsection shall include, but not be restricted to, any container from which the top has at any time been removed, regardless of whether it has been replaced, and in the case of a sealed container, any container on which the seal has been broken.

(3) Sell any of the alcoholic beverages described in section 6-21 to any person who is less than 21 years of age.

The provisions of this section shall be applicable to holder of class AR permits under this chapter.

ARTICLE II BEVERAGES OF HIGH ALCOHOL CONTENT

DIVISION 1. GENERALLY

Sec. 6-116. - Prohibited activities of licensees and permittees.

No holder of a retail dealer's license and permit issued under this article, and no servant, agent or employee of such licensee and permittee shall:

- (1) Commit or do on the licensed premises any of the acts and things prohibited by the provisions of R.S. 26:286, all of which are made a part hereof, by reference, for all purposes as fully as if written herein in extenso. A violation of this section by a retail dealer or retail dealer's agent, associate, employee, representative, or servant shall be considered the retail dealer's act for purposes of suspension or revocation of the permit. Violation of this section is sufficient cause for the suspension or revocation of a permit.
- (2) Sell, store, use, consume, handle, give away or otherwise dispose of any of the beverages described in section 6-114 between the hours of 1:00 a.m. and 6:00 a.m. daily and to conduct the operation of said business between the hours of 2:00 a.m. and 6:00 a.m. daily, except as provided by section 6-2. Restaurants, grocery stores, drugstores, gaming facilities (including riverboat casinos) or other business may remain open for the sale of other items permitted by law, but any sale or consumption of alcoholic beverages in such places of business during the prohibited periods set forth above is expressly prohibited. During the prohibited periods, no open glasses, bottles, cans, or other containers holding alcoholic beverages shall be allowed anywhere on the licensed premises except in a locked cabinet or cupboard; provided, that those businesses which maintain separate rooms for the conduct of the business of dealing in alcoholic beverages may securely close and lock said separate rooms. An Ordinance To Amend And Reenact The West Baton Rouge Parish Code Of Ordinances, Part II ("Code Of Ordinances"), Chapter 70 ("Roads And Drainage"), Section 70-2 ("Obstruction Of Waters, Drains, And Drainage Canals") To Provide For Enforcement Of Drainage Servitude Obstructions.

WHEREAS, one of the primary functions of local governments is to protect the health, safety and welfare of its people; AND

WHEREAS, in exercising its role to carry-out the above, the West Baton Rouge Parish Council utilizes its police powers under the Constitution and laws of the State of Louisiana; AND

WHEREAS, such exercise of police power involves from time-to-time creating or amending local development (and other) laws in order to protect the public; AND

WHEREAS, one exercise of said police power involves the establishment and preservation of servitudes for the purposes of drainage; AND

WHEREAS, the Council finds that some property owners have obstructed established drainage servitudes either with their knowledge of such obstruction or by accident AND;

WHEREAS, the Council and the Louisiana State Legislature has heretofore provided for the enforcement of certain development-related nuisance remedies.

NOW, THEREFORE, BE IT ORDAINED that the West Baton Rouge Parish Code of Ordinances, Part II ("Code of Ordinances"), Chapter 70 ("Roads and Drainage"), Section 70-2 ("Obstruction of waters, drains, and drainage canals") be amended and readopted to read as follows:

(NOTE: underlined words are additions and strikethrough words are deletions. Three asterisks - * * indicate sections of the code skipped for brevity of this ordinance. Such sections are to be retained by the code editors.):

PART II - CODE OF ORDINANCES

CHAPTER 70

ROADS AND DRAINAGE

Sec. 70-2. – Obstruction of waters, drains, and drainage canals, and drainage servitudes.

Prohibited. It shall be unlawful for any person, firm, association or corporation to willfully obstruct any waters, drains or drainage canals of the parish by dumping or discharging or causing to be dumped or discharged, or permitting to be dumped or discharged into any such waters, drains or drainage canals any trees or other objects, articles, substances or materials whatsoever. Additionally, it shall be unlawful to prohibit the Parish from accessing, and/ or traversing, and/or maintaining the areas inside of Parish drainage servitudes.

Evidence of violation. Should any person, firm, association or corporation who has dumped, discharged, caused or permitted to be dumped or discharged any such objects into the waters or drains or drainage canals of the parish fail to remove the same at his own expense within a period of ten days from receipt of notice of such obstruction, such failure on his part shall constitute prima facie evidence of willful intent to obstruct such water, drain or drainage canal within the meaning of this section. Additionally, should Parish employees be unable to access, and/ or traverse, and/or maintain the areas inside of Parish drainage servitudes, such documented obstructions shall constitute prima facie evidence of willful intent to obstruct the same.

(c) Administrative Adjudication Court. Alleged violations of this Section shall be deemed "nuisances" and shall be brought before the West Baton Rouge Parish Administrative Adjudication Court that has been established elsewhere in the Louisiana Revised Statutes and the West Baton Rouge Parish Unified Development Code.
