An Ordinance To Amend And Reenact The West Baton Rouge Parish Code Of Ordinances, Part III (“Unified Development Code”), Chapter 106 (“Site Planning”), Article II (“Stormwater Management”), Section 106-21 (“Stormwater Quantity Control In Commercial And Industrial Developments”), And Chapter 111 (“Administration And Enforcement”), Article VI (“Subdivision Approval Procedure”), Section 111-114 (“Construction Plans”) To Provide For Stormwater Quantity Control In Most Developments.

WHEREAS, one of the primary functions of local governments is to protect the health, safety and welfare of its people; AND

WHEREAS, in exercising its role to carry-out the above, the West Baton Rouge Parish Council utilizes its police powers under the Constitution and laws of the State of Louisiana; AND

WHEREAS, such exercise of police power involves from time-to-time creating or amending local development (and other) laws in order to protect the public; AND

WHEREAS, ensuring proper management and maintenance of existing and proposed stormwater systems is directly relevant to protection of public health, safety, and welfare; AND

WHEREAS, West Baton Rouge Parish has previously established criteria requiring detention of certain types of design storm runoff and now wishes to provide additional clarification and criteria;

NOW, THEREFORE, BE IT ORDAINED that the West Baton Rouge Parish Code of Ordinances, Part III (“Unified Development Code”), Chapter 106 (“Site Planning”), Article II (“Stormwater Management”), Section 106-21 (“Stormwater quantity control in commercial and industrial developments”), and Chapter 111 (“Administration and Enforcement”), Article VI (“Subdivision Approval Procedure”), Section 111-114 (“Construction plans”) to provide for stormwater quantity control in most developments be amended and readopted to read as follows:

ARTICLE II. – STORMWATER MANAGEMENT

Sec. 106-21. – Stormwater quality control in commercial and industrial developments.

As part of the building permit/site plan review approval process for multi-family residential, commercial and industrial new construction or expansions in which the following combinations of lands are ~~disturbed and impervious surface created, in instances where the percentage of the site’s, lot’s, tract’s, or parcel’s total impervious ground surface meets or will meet (after the proposed construction)~~ a 45% (~~forty-five percent~~) threshold, the applicant shall demonstrate to the director of public works (or his or her designee) that the proposed development construction does not increase existing stormwater runoff peak flow rates and water surface elevations to neighboring businesses or the existing stormwater system (“no net increase”). Stone-stabilized improved surfaces shall be considered impervious surfaces. Methods for maintaining existing stormwater volumes, water surface elevations and peak rates is at the discretion of the developer, but the parish encourages the use of detention ponds, bioswales, infiltration systems and other stormwater management technologies that also demonstrate a reduction in pollutant loading ~~as well. In demonstrating no net in-~~

crease, the applicant shall retain a Louisiana licensed civil engineer to submit a drainage impact study. The required study shall be performed on the 25-year and 100-year design storm using the rainfall intensity and durations provided for in West Baton Rouge Code of Ordinances Section 111-114(c). If no development has begun within 24 months following the acceptance of the drainage impact study by the Parish, a new drainage impact study will be required.

(c) As part of the parish’s review of subdivision construction plans, all proposed subdivisions shall submit a drainage report stamped and signed by a licensed Louisiana civil engineer. Such report shall detail the drainage calculations and show how each drainage facility (e.g., culverts, ditches, ponds) was sized based on the procedures demonstrated in the state department of transportation’s Hydraulics Manual. All drainage improvements shall be designed to handle a twenty-five-year frequency, three-hour duration (6.5 inches) rainfall event as predicted in the Southern Regional Climate Center Technical Report 97-1, Rainfall Frequency/Magnitude Atlas for the South-Central United States,” Faiers et al, 1997. All drainage reports shall also contain a signed statement attesting that the subdivision drainage design has been checked against the 100-year frequency, three-hour duration (eight inches) rainfall event as predicted by Faiers et al. Such check shall ensure that the hydraulic grade line, or water surface, will not enter into homes with minimum floor elevations at one foot above the centerline of the road or two feet above surrounding ground in subdivisions adjacent to built-up roadways and setback at ten feet from any drainage feature being examined. Such certification note shall read as follows:

I certify that I am a currently licensed Louisiana civil engineer and that I meet state law requirements allowing me to engineer drainage facilities. I have checked (calculated water surface elevations for) this entire subdivision proposal against the 100-year, three-hour rainfall (eight inches) predicted by Faiers et al (1997 SRCC Technical Report 97-1) for West Baton Rouge Parish. I further certify that the calculations demonstrate that any home built one foot above the centerline of any road in this subdivision (or two feet above surrounding ground in the case of built-up subdivisions) and ten feet away from any drainage facility shall not be subject to flooding under the same 100-year, three-hour rainfall event. (Flooding is defined as water entering the home at the minimum slab elevation level.)

The applicant shall demonstrate to the director of public works (or his or her designee) that the proposed subdivision does not increase existing stormwater runoff peak flow rates and water surface elevations of the existing upstream and downstream stormwater system (“no net increase”). Methods for maintaining existing stormwater volumes, water surface elevations and peak rates is at the discretion of the developer, but the parish encourages the use of detention ponds, bioswales, infiltration systems and other stormwater management technologies that also demonstrate a reduction in pollutant loading as well.

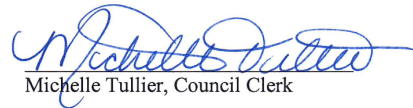
