### **DECLARATION OF ELECTION RESULTS**

Be it known and declared that Hon. Tony Clayton, District Attorney of the 18th Judicial District (the "District Attorney"), acting as the governing authority and Chief Executive Officer of the 18th Judicial Enforcement District of the Parishes of Iberville, West Baton Rouge and Pointe Coupee, State of Louisiana (the "District"), did meet in open and public session to examine the official certified tabulations of votes cast at the special election held in the District on Saturday, April 27, 2024, and did examine and canvass the returns of the said election, there having been submitted at said election the following proposition, to wit:

### PROPOSITION (SALES TAX)

Shall the 18<sup>th</sup> Judicial Enforcement District of the Parishes of Iberville, West Baton Rouge and Pointe Coupee, State of Louisiana (the "District"), be authorized to levy and collect a sales and use tax of 0.25% (the "Tax") (an estimated \$8,273,000 reasonably expected to be collected from the levy of the Tax for an entire year), for a period of 10 years, commencing July 1, 2024, in accordance with Louisiana law, with the proceeds of the Tax (after paying reasonable and necessary costs and expenses of collecting and administering the Tax) to be dedicated and used for the purpose of providing funding for the offices of the District Attorney for Iberville, West Baton Rouge and Pointe Coupee Parishes?

There was found by said count and canvass that there was a total of **5,411** votes cast **IN FAVOR OF** the Proposition and a total of **4,872** votes cast **AGAINST** the Proposition, as hereinabove set forth, and that there was a majority of **539** votes cast **IN FAVOR OF** the Proposition as hereinabove set forth. Therefore, it has been declared by the governing authority of the District that the proposition as hereinabove set forth was duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special election held in the District on Saturday, April 27, 2024. Results by precinct are available from the District Attorney during regular business hours or via the Louisiana Secretary of State's website (vo-

terportal.sos.la.gov). The actual cost of the election as determined by the Louisiana Secretary of State in accordance with the provisions of Chapter 8-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended, is \$122,234.56.
