

ELDORA CITY COUNCIL MEETING MINUTES OF JANUARY 20, 2026

CALL TO ORDER

The regular meeting of the Eldora City Council was called to order by Mayor Denny Barnard at 6:00pm on Tuesday January 20, 2026, in the Council Chambers.

PLEDGE OF ALLEGIANCE

ADOPTION OF AGENDA
