# Eight more deaths linked to COVID

The death toll in Del Norte County from the COVID-19 virus has risen to 18; with eight

August 13. As of press time, 25 are hospitalized due to the virus.

Additionally, the county reported 139 new cases over the week-

end, bringing the active case total

of those deaths occurring since

to 417 — yet another pandemic high for Del Norte. There were also 17 new incarcerated cases, which moves the active case count among inmates at Pelican Bay State Prison to 49. Currently, Pelican Bay has the most active cases of COVID-19 among California Department of Corrections and Rehabilitation facilities.

The newly appointed Public Health Officer for Del Norte

County Dr. Aaron Stutz outlined the dire situation in the county and at Sutter Coast Hospital, where he works as an emergency physician.

"We have 22 admitted COVID patients out of 38 admitted patients at the hospital as a whole. We have nine COVID patients in the ICU, seven of whom are intubated on ventilators. We have six more COVID patients in the emergency department that are

waiting to be admitted," said Stutz during a Tuesday county board of supervisors meeting.

According to Stutz, the hospital had three available beds in the emergency department on Friday, but that number shrank to just one by Monday.

"It was a frustrating situation; you just can't run an emergency department like that. People can't get seen for their normal issues that are outside of COVID, or even if they have COVID, they can't get seen in the emergency department," said Stutz.

Stutz said the majority of COVID patients being admitted to the hospital are younger than 65 years old, and recently they saw their first pediatric hospitalization since the beginning of

# Long closures ending at Last Chance Grade

Long closures at Last Chance Grade will finally come to an end this Monday.

The small stretch of Highway 101 between Crescent City and Klamath, known as Last Chance Grade, has been hampered with long work closures since a landslide swept over the road in February. In July, CalTrans extended daily closures from two to four hours in an effort to speed up the clean-up operation — a move that worked according to Sebastian Cohen, project manager with CalTrans.

"We've met our goal of removing all of the material, which was the critical thing to do with these four-hour closures, the rest of the work can be done from a closed lane," said Cohen. "It's a challenging site with very limited room. We love to keep traffic going and we would have if we could, but for everyone's safety we had to do it this way."

Remaining work at Last Chance includes completing the installation of a special mesh, which is designed to knit together the slope to prevent a future catastrophic slide, as well as catch any falling debris, according to Cohen. So, while the road will remain open to one-lane traffic at all hours of the day, motorists should still expect up to 30-minute delays.

What's more, a separate project just a couple hundred feet away from the landslide cleanup is expected to wrap sometime in the fall of 2022, meaning, Last Chance Grade could open up to two-lane traffic for the first time since 2014.

While the end of long work closures will come as a relief to many Del Norte residents, the fix is not meant to be long-term.

# Sanders' autopsy raises more questions

An autopsy report for Tamera Sanders — a local woman whose body was discovered in a burned down barn in May — raises more questions than answers.

The body of 29-year-old Sanders was discovered by sheriff's deputies following a fire at a barn on Bertsch Avenue and Howland Hill Road. Since then, the Del Norte Sheriff's Office has been investigating the suspicious death.

According to the autopsy report, which the Triplicate recently obtained, Sanders died due to carbon monoxide poisoning from smoke inhalation. However, the state medical examiner could not conclude whether her death was malicious or accidental — leaving the manner of death "undetermined." The examiner did conclude methamphetamines were present in Sanders' system during her death.

The report also reveals more details from the night of the incident.

According to the report, the building was completely engulfed in flames around midnight on May 2. Around that time the owner of the building,

# Experience key for the Warriors as they prepare for season opener

The Del Norte Warriors will kick off the new high school football season on Friday night, with Enterprise High traveling to Crescent City for varsity and JV games.

This year's Del Norte varsity squad features plenty of experience, with seven of last season's 10 all-league selections back with the team.

That group includes senior

first-team all-league selection Sam Schauerman, who is expected to anchor both lines for the Warriors and is described as "arguably the best lineman in the league" by head coach Nick White.

The third-year varsity player will be joined on the offensive line by fellow seniors Trevor Freeman and Konner Price, as well as junior Jacob Dane, all three of whom were all-league

honorable mentions last season. Another senior, Aidan Thomas, rounds out the starting offensive line, with senior Hunter Giddings getting the nod at tight end.

It's a unit that has been a traditional strength for the Warriors and one that is expected to be so again this fall, as they look to play a physical brand of football and establish the run first.

"We're going to do what we do and see what happens," White said. "Every kid is a little bit better at each position."

A trio of talented running

backs are expected to see significant minutes, including returning senior Caleb Dodson, who was an all-league first-team selection last season, as well as juniors Giancarlo Desolenni and RJ Loftin, each of whom was an all-league honorable mention last season.

The experience of having so many players back from last year already looks like it's pay-

ing dividends.

"The kids have definitely taken a step up as leaders, with their

execution and their confidence," White said. "Everything that goes along with having a year under your belt."

The Warriors will also try to establish a physicality on defense, with Schauerman and the rest of the line once again expected to set the tone.

"It's going to be a group effort," the head coach said of his defense. "We have a good

who lived nearby, allegedly heard a woman screaming.

Sanders' was a known homeless resident of the community, and according to local homelessness officials, she was also known by the alias, "Magica." The sheriff's office urges the public to come forward if they have any information regarding her death.

"Tamera may have been experiencing challenges towards the end of her life, but it is important to remember that she was a mother, daughter, loved one and friend," wrote the sheriff's office in a Facebook post last month.

"If you have any information that may help conclude this investigation and bring closure to her family, please contact the Del Norte County Sheriff's Office at 707-464-4191. It should also be mentioned that if this case is determined to be a homicide, family and friends are offering a reward for information leading to a conviction."

Earlier this year, though, CalTrans and other contributing agencies zeroed in on two possible solutions to the Last Chance Grade problem: Alternative F and Alternative X.

Alternative F proposes a half mile tunnel into the slope intended to avoid the landslide hazard altogether. While the tunnel carries a hefty price tag with an estimated \$1.3 billion in construction costs, it would also have the smallest environmental footprint out of the remaining alternatives, according to CalTrans. The estimated construction

schedule for Alternative F is seven years.

The proposed tunnel would be similar in length and features to the Tom Lantos Tunnels at Devil's Slide on Highway 1, south of Pacifica in San Mateo County, California.

Alternative X is a cheaper solution, and a little more complex. Alternative X proposes an "end-to-end" re-engineering of the current alignment of Highway 101, intended to mitigate the landslide hazard. A re-engineering would include moving the road slightly east in key locations, dewatering the slope to minimize movement, additional retaining walls,

and regrading the adjacent hillside to a flatter angle. The estimated price tag for Alternative X is \$500 million and the estimated construction schedule is 3 and a half years.

Del Norte County Supervisor Bob Berkowitz said he's skeptical of both remaining alternatives.

"I don't put faith in either one of them," he said.

Berkowitz said the state will probably not fund a project as expensive as Alternative F, and Alternative X seems unlikely to fix the inherent problems at Last Chance.

"It has a history of swallowing into the ocean and killing people," he said. "I wanted something that

was going to be reasonably priced, do-able and to prevent the slides we've had for the last 20-30 years."

However, Cohen argued Alternative X is not "more of the same."

"I've been starting to repeat that as much as I can to the board of supervisors and anyone that's interested because it is a much more significant repair strategy," said Cohen. "We have a laundry list of tools and techniques that we are considering at all locations for the entire length of Last Chance Grade. So, there are a lot of things to be determined on exactly what we do with X, but it's an alternative that has everything

under the sun in it."

Cohen said the key to Alternative X's success is dewatering the slope using drainage tunnels, also called adits.

"If you can get rid of the water, you can have a significant impact on stabilization," he said.

Whatever the long-term solution may be, Berkowitz said Crescent City likely missed out on many tourism dollars this summer due to the most recent work closures.

"Having a long-term closure prevents a lot of people, who would come on Highway 101, now picking Highway 5 just because it has been too difficult to get through on 101."

Right now, CalTrans is predicting construction on a long-term solution to Last Chance to begin around 2030.

# Huffman, Lieu announced launch of California Coastal Caucus

Congressman Jared Huffman (CA-02) and Congressman Ted W. Lieu (D-Los Angeles County) recently announced the launch of the Congressional California Coastal Caucus at The Marine Mammal Center in Sausalito, California. The caucus will bring together members of the California House delegation to share and discuss federal policy to address matters of importance to the 840-mile California coast, including issues relating to the environment and economy. Congressman Lieu and Congresswoman Julia Brownley (CA-26) will serve as co-chairs of the caucus. Additional members of the caucus include U.S. Representatives Eric Swalwell, Nanette Barragan, Alan Lowenthal, Jimmy Panetta, Jared Huffman,

Mike Levin, Ro Khanna, Jackie Speier, Salud Carbajal, Barbara Lee and Anna Eshoo.

Congressmembers Huffman and Lieu participated in a tour of The Marine Mammal Center, followed by a roundtable discussion moderated by Carol Costello with Dr. Jeff Boehm, chief executive officer of The Marine Mammal Center, and Dr. Cara Field, medical director of The Marine Mammal Center, on the importance of the ocean in the fight against climate change.

"California's scenic coastline is admired around the world, and I have the honor of representing and working to protect – some of the most beautiful parts of it on the North Coast. Our state has long been a national leader in the ocean and environment space,

and those lucky enough to represent coastal districts like mine have a responsibility to continue setting an example for the rest of the country," said Rep. Huffman. "That patient was flown out to a pediatric facility in the Bay Area and is in critical condition," said Stutz. "For those people in the community who tend to play down the danger of COVID for younger people, I would say it is a very real threat."

During the meeting, Supervisor Valerie Starkey asked Stutz if the county public health department had maintained contact tracing efforts, as she heard idents were not contacted by public health.

Despite receiving five additional contact tracing workers from the state, Stutz admitted the county has fallen behind on tracing due to the overwhelming surge.

"At a time like this it does become extremely difficult to perform adequate contact tracing...Once we progress beyond a certain number of cases per day, it becomes almost impossible to track down all the contacts of all the positive cases," he said.

Starkey also asked Stutz about monoclonal potential treatment for mild and moderate cases of COVID-19.

According to the U.S. Food and Drug Administration, monoclonal antibodies are laboratory-made proteins that mimic the immune system's ability to fight off harmful antigens such as viruses. Sotrovimab is a monoclonal antibody that is specifically directed against the spike protein of COVID-19, and is designed to block the virus' attachment and entry into human cells. The FDA approved emergency use of monoclonal therapy for COVID-19 in May. Stutz said the Sutter

Coast Community Clinic has begun offering monoclonal treatment from 7 a.m. to 7 p.m. through a partnership with the state. Nevertheless, he said monoclonal treatment of

COVID-19 is questionable. "It's controversial in the health world as to its efficacy," said Stutz. "I don't want to promote the therapy in place of just getting the vaccine; the vaccine is much more preventative and much more effective. [Monoclonal therapy] is something for if you've already had COVID, or had a significant exposure such that you're likely to get COVID and that you have significant medical problems to boot."

Individuals can also receive COVID-19 testing and vaccines at the community clinic during the same hours.

Supervisor Gerry Hemmingsen asked Stutz about other controversial treatments such as ivermectin, a medicine commonly used to treat parasites in livestock.

Stutz said there is some evidence of ivermectin being effective in fighting COVID, however, there is still not enough data to fully support those claims.

'Most physicians would be willing to give patients medication like this if there was concrete data showing that it would help their medical situation. We're not generally swayed very much by the commercialism and the politics, we just want to see concrete data in place before we start giving mysterious medication to

people," said Stutz.

According to local public health officials, the most effective method to prevent contraction of COVID-19 is to get the vaccine, yet the vaccination rate in Del Norte County is among the lowest in the state, with 42% of people fully vaccinated. In neighboring Humboldt County, 51.7% of the population is fully vaccinated.

Recently, the Centers for Disease Control recommended vaccine booster shots for immunocompromised individuals who received the Pfizer or Moderna vaccines. The CDC also said eligibility for booster shots would open up to all individuals who received the Pfizer or Moderna shot this fall, with individuals becoming eligible eight months after they received their second dose.



In my opinion, that's a good thing. Generally speaking, we're all better off when personal health decisions are left to individuals than when government presumes to make those decisions for everyone.

Many Americans began voluntarily donning masks when "public health authorities" were still yelling at us not to, and drastically reducing our outings and interactions before governments started trying to put us all (well, all of us toffs who could stay home and watch Netflix while "essential" peons delivered our groceries) under house arrest. Policy is a trailing, not leading, indicator.

Grain of salt warning: "The plural of the word anecdote," Kenneth Kernaghan and P. K. Kuruvilla wisely noted in 1982, "is not data." I'm not equipped to conduct a nationwide, well-controlled, peer-reviewed study on the subject. I can only tell you what I've noticed and what others I know have seen.

New Mexico blogger Kent McManigal notes at "Hooligan Libertarian" that, although that state's government has re-imposed its previous mask mandate, about 25% of shoppers seem to be ignoring it, and that stores aren't hassling those shoppers about it.

I follow the news closely by profession, but I didn't even notice when my county' s government (Alachua County, Florida) re-imposed its mask mandate. My wife

I didn't have a mask with me, and was about to return to the car, when I noticed two things: First, the store hadn't put up signs at the door advising shoppers of the re-imposed mandate. Those signs had been there throughout the first mandate. Second, looking through the door, I could see unmasked shoppers inside, and nobody

walk into our neighborhood grocery store.

appeared to be giving them any trouble. So, I just went in. My experience matched Kent's. More than half the shoppers were masked, but nobody gave the unmasked so much as a cross look.

On our next outing, I brought a mask with me, just in case.

At one store, the proprietor had been clear through the pandemic that it was not his job to enforce county mask mandates. The county government sign wasn't back up, and the "masks optional" sign still was. I shopped unmasked without incident.

At another, the county government sign WAS up, but I saw not a single employee, and only a few customers, wearing masks. When in Rome ...

A third store had its own - not government-printed or referencing any law - "masks required" sign. I masked up, went inside, and noticed that most (not all) customers were complying, and that nobody was beating anyone up over it.

I don't much care whether people choose to wear masks or not. If it makes you feel better, knock yourself out.

But it's good to see Americans deciding for themselves instead of just doing as they're told.

# The Colorado River is sending us a message

It feels like an apocalypse in the Southwest – wildfires, floods, drought, heat, smoke. This was not the norm when I moved to Colorado 35 years ago. Climate scientists may have predicted the arrival of these extreme events, but many admit their predictions have come true faster than they expected.

One outcome they pinpointed was the impact of heat and drought on water flows in the Colorado River. For the last 20 years this new climate, combined with booming human population growth, has parched landscapes, drained reservoirs and incited talk of water wars across the region. Lake Powell on the Colorado River, and Glen Canyon Dam which creates the reservoir, have become casualties of this strained environment.

Lake Powell is the second largest reservoir in the United States, but in the last year alone its water level has dropped 52 feet and the reservoir now sits at 31.4% full.

If you're a pessimist, that's over 68% empty. Water managers are already imposing cuts in water deliveries in some states; all their choices are filled with political pitfalls.

A further complication is that the federal government operates a hydroelectric plant at Glen Canyon Dam that provides cheap electricity to parts of the Southwest. The day is coming when the hydroelectric turbines will stop for want of water to spin them.

To save the lake and generate electricity, the

government needs water. But where will that water come from?

Upstream of Lake Powell, in Utah, Colorado, Wyoming and New Mexico are millions of acres of irrigated farms and ranches that suck massive amounts of water out of the Colorado River before it reaches Lake Powell. If those farms and ranches quit taking water and instead ran that water downstream, the lake and its electricity could be saved. To ensure that outcome, the federal government has hatched a plan it calls "demand management," which proposes to buy or lease massive amounts of farm and ranch water to prop up

Lake Powell. On the one hand, the farmers and ranchers would get paid for the water, and likely paid very well. If I were a rancher who owned water, I'd sit comfortably until the offering price for my water made me even more comfortable.

On the other hand, lots of people and businesses believe that irrigated farming, ranching and outdoor recreation are not only central to the region's economy, but also to its culture. Should that economy -

and the soul of the Southwest — be sacrificed to save a manmade reservoir and its hydroelectricity?

I'm torn by this dilemma. If farms and ranches are dried up, more water flows down the river. More water in the river benefits fish and the environment. But there's another solution: We can save farms and ranches and instead drain Lake Powell, freeing the Colorado River to flow free through 169 miles of a drowned and beautiful place called Glen Canyon.

# Tree rings from old growth Douglas firs on the Oregon Coast show evidence of 1700 tsunami

Core samples taken from a stand of old growth Douglas-fir trees in the South Beach area just south of Newport showed reduced growth following the 9.0 earthquake and subsequent tsunami that struck the Pa-

from the Douglas-fir tree rings confirms modeling that depicts the reach of the January 1700 quake, which was the last major earthquake to hit the Cascadia Subduction Zone, said Robert Dziak,

a Hatfield Marine Science Center-based scientist with The physical evidence the National Oceanic and Atmospheric Administration Pacific Marine Environmental Laboratory. "The tsunami appears

to be the event that most affected the trees' growth that year," said Dziak, whose work includes ocean acoustic studies. signal analysis and tsunami modeling. He also holds a courtesy appointment in Oregon State University's College of Earth, Ocean,

and Atmospheric Sciences. "Getting these little bits of the picture helps us understand what we might expect when the next 'big one' hits."

The findings were published recently in the journal Natural Hazards and Earth System Sciences.

The idea for the study dates back more than a decade; Dziak was aware of past research that had shown evidence of the 1700 quake in trees in Washington, and thought

it might be worth seeing if similar evidence existed in Oregon.

The first challenge was finding a stand of old growth Douglas-firs in the tsunami inundation zone. The researchers looked at a few places before locating the stand in Mike Miller Park in South Beach, about two kilometers south of Yaquina Bay and 1.2 kilometers east of the present-day ocean shoreline.

"We're not sure why this tree stand wasn't logged

over the years, but we're very fortunate to have a site so close to the coastline that has survived," said coauthor Bryan Black of the Laboratory of Tree-Ring Research at the University of Arizona, Tucson.

A new and updated tsunami model run by the researchers as part of the study shows that the area could have been inundated by up to 10 meters of water in the 1700 tsunami event, said Dziak
