# Howard wins new term as District 3 supervisor

# District 4 runoff candidates Adams and Stone 11 votes apart

Incumbent District 3 Supervisor Chris Howard scored a complete victory in the June 7 primary election. Howard secured 627 votes, or 56.75 percent of the total votes cast, and will avoid a runoff election in November. His third term of office begins in early January 2023.

Howard soundly defeated Frank Magarino who received 254 votes, or 23 percent of the total, and Joe "Hank" Akin who received 224 votes, with 20.27 percent of the votes.

District 4 supervisorial candidate Joey Borges was far out front with 44.67 per cent of District 4 votes, surpassing second place finisher Patty Adams, with 234 votes, or 25.19 percent of the votes. Because neither candidate received more than 50 percent of the vote, they will face each other in the runoff election in Novem-

Brian Stone placed third in the District 4 race, with 223 votes just 11 votes behind Adams. Margaret Sargent received 57 votes, or 6.14 percent of the total.

There may still be some ballots left uncounted in District 4 that could affect whether Adams or Stone proceeds to the November runoff election.

Ballots postmarked on or before June 7 that had not yet been received, and provisional ballots that withstand scrutiny by election officials, may close the gap between Adams and Stone and possibly alter which candidate

moves on to face Borges in the November runoff election.

In District 5, the seat vacated by the passing of the late Supervisor Bob Berkowitz, two strong candidates will face each other in November.

Former Sheriff Dean Wilson placed first of five candidates; he received 349 votes –39.75 percent of the total.

Appointed incumbent Supervisor Susan placed second with 298 votes, or 33.94 percent. Far behind were Terry Colton, who received 96 votes; David Jones, with 82 votes; and David Markel with 53 votes.

Officials seeking reelection to countywide offices all ran unopposed, and hence, received 100 percent of the votes cast for

They include Treasurer-Tax Collector Barbara Lopez; County Clerk-Recorder Alissia D. Northrup; County Assessor Jennifer Perry; Auditor-Controller Clinton Schaad; District Attorney Katherine Micks; Sheriff-Coroner Garrett Scott; and Superintendent of Schools Jeff Harris.

#### **Dan Barnts**






#### Khou Vue





#### Jagger Fruth



#### **Daphne Cortese-Lambert**



# Six Rivers National Forest celebrates 75 years

The Six Rivers National Forest is celebrating its 75th anniversary! On June 3, 1947, President Harry S. Truman established the Six Rivers National Forest by

Presidential proclamation 2733 creating the youngest forest in California.

The forest has grown in many ways over the past 75 years. For example,

the forest now has almost 75,000 more acres than it did when it was established. The Six Rivers' initial 900,000 acres was a combination of three



and Trinity (now the Shasta-Trinity) national forests in the Pacific Southwestern Region. Today the forest is comprised of 974,612 acres of mountainous land and iconic rivers that stretches from the Oregon-California border south for approximately 140 miles to

Mendocino County. Not only has the acreage grown but so has the workforce. In 1947 there were only 9 employees on the forest which included rangers and staff. Today the forest employs around 200 people across four districts

and the Supervisor's Office.

Seventy-five years later the Six Rivers National Forest remains committed to connecting people to the land, working in collaboration with our communities and partners, and providing access to resources that promote economic, ecological, and social vitality.

# Can we remain the Land of the Free and the Home of the Brave?

Once again, we face the horror of another mass homicide, another school shooting. This time, it was 17 children and two teachers in Ulvalde, Texas, who were massacred by an angry 18-year-old with a gun.

This one person determined to commit a mass homicide crashed his car through the schoolyard fence to gain access to his victims after he had killed his own grandmother.

It is easy for some to blame the gun; it was the final instrument this murderer used to carry out his hateful deed. One more criminal; one more mass shooting; and one more outcry to erode the rights and freedoms of many millions of citizens who lawfully own, possess and are capable of using firearms to protect themselves and their families from exactly this kind of threat.

There is no similar demand to ban automobiles, hand tools, kitchen knifes and other instruments that are often used to inflict deadly violence. Guns are targeted because they are designed to stop an imminent threat. Guns can kill from a distance. Cars and kitchen knives serve other purposes and are effective weapons only under close proximity.

Must a victim submit to an attacker? The outcome is predictable when a murderer attacks an unarmed person. Perhaps a teenager, a frail senior citizen, a sick or injured person, or just someone who is distracted while walking by. The threat, as we are now reminded, is real. The consequences are deadly.

Mass murderers can carry out their crimes because their unarmed victims cannot shoot back. Certainly, adults under whose care the safety of these children depended, would have responded much sooner than the nearly one hour it took for police to take appropriate action. Willing adults can be provided the necessary training.

When properly trained and armed civilians can make all the difference. An armed citizenry would, by the general knowledge of its very existence, serve as a deterrent for all manner of crimes, and would probably stop the more determined criminal dead in his tracks.

Will the Second Amendment right to keep and bear arms be watered down to suit those who live in a constant state of fear? An armed citizenry can exclude persons with a history of violence, drug or alcohol abuse, serious mentally illness, or those who don't pledge allegiance to the United States. An armed citizenry can provide a buffer of safety that an understaffed, overworked, inexperienced police department can not always be counted on to provide.

We live in an era of decriminalization, early release of inmates following reduced sentences, and accused criminals who are released immediately back into the streets rather than remain locked up while awaiting justice.

We must defend our freedom to keep and bear arms more than ever before.

Because we can't always wait for the police to respond in time, our loved ones may depend upon our ability terminate the threat. Rather than becoming defenseless and fearful, America and Del Norte County must remain the "Land of the Free, and the Home of the Brave."

# View from the left More grants do more good

In my last column I said, "Sometimes a single one-time grant will build enough momentum to start and maintain a project that would otherwise not be feasible." Today I want to highlight an example of a grant that is doing just that.

The Tiny House Workshop sounds like something you would find at the North Pole. But this workshop is right here in Del Norte County. The Tiny House Workshop is a project of the Del Norte High School career and technical education classes. In this program students gain job training and practical experience in all aspects of construction as they build a tiny house.

Without grant funding this project would not be where it is today. According to a story in the Wild Rivers Outpost (5/31/22), the Tiny House Workshop was built using a \$693,000 California Careers Technical Education Facility Grant and \$152,698 in voter-approved bond dollars.

The construction of this workshop provides space for the Tiny House Program where the students can learn to build houses out of the rain. They have just sold their first tiny house and plan to use the proceeds to continue the program and buy materials for construction of the next tiny house, thus perpetuating funding for the program.

What I love about this program

is that it is bringing grant funds into our community that have a combined benefit of technical education, employment training and a tangible product. This program will build functional tiny houses that can be installed as accessory dwelling units which will help our housing shortage.

This is a win, win, win. Go Warriors!

I understand why some government employees do not pursue grant funding. You must do extra work to apply for a grant, then you will have to do extra work if you get the grant. But this did not dissuade one creative government employee who is helping to grow a small, but important local program.

Danny Clark was hired last November by the Del Norte County Library District to be the new Literacy Coordinator for Del Norte Reads, a program targeted to empower community members through literacy education.

However, after hearing about the deficiencies in our youngest learners caused largely by two years of COVID restrictions, Mr. Clark was inspired to propose a new Family Literacy Project. This will support parents as primary reading teachers by providing materials, coaching and additional teaching aids.

Danny Clark didn't wait for someone else to figure out how

to fund this project. He found grant funding through the California Library Literacy Services and

expects to receive a \$30,000 grant in July which will fund salaries and operations to enable a full-scale Family Literacy Project.

"This grant effectively doubles the budget of this program and I anticipate this grant will be available for the next five years," explains Mr. Clark. "The extra funding will enable us to create a new job and hire an additional employee to help expand the program."

This is a good example of how one person and a relatively small grant can make a big difference.

# Eye on Del Norte Blight is taking over the landscape

What's the answer for blight?
Del Norte is truly a beautiful
county... in most places. Does
Del Norte County possess some
of the most awesome redwood
forests and magnificent coastline
and beach seascapes on the North
American continent? Yes. But
there are certainly no shortages of
eyesore blighted properties spewed
about in every district in Del Norte
County.

Human-created blight has and continues to be a major sore spot. All candidates for the three county supervisor district races have acknowledged the blight issue, but in their campaign rhetoric none have offered any solutions.

Just how does one grab a handle on blight and propose to clean up and keep maintained theses ugly messes some folks have irresponsibly created? Lots of chatter, a whole lot of finger-pointing, very little engagement on this growing disregard and recognition on the appearance of landscape ugliness in Del Norte County.

Government is not the answer. We cannot expect government to solve this growing problem of blight. Solutions to address blight are expensive and money-centered, and tediously slow in resolution. I'm sad to say, the community is not winning the battle against blight.

Truth be told, there will never be enough public funds to satiate the desire of some to "clean up the mess" for those who do not share this viewpoint.

Our Del Norte County Dept.

of Community Development oversees Code Enforcement with a two-person team; the second employee was recently hired. Here are the essentials you need to know:

• The current County caseload is about 150 active cases; 95 percent are blight-related and directly caused by our fellow human beings.

• "Blight Court" meets monthly and is the venue where code violations and nuisances are addressed.

Blight Court is not a criminal court. The impartial hearing officer has three options available to mitigate blight: 1) Declare that the blight that is the subject of the complaint is not a nuisance; 2) Declare the blight is a nuisance; and 3) If so declared, the hearing officer may then give the offender a reasonable time to correct the violation, or refer the violation back to Code Enforcement for remediation.

Penalties vary from imposing the requirement to correct the violation, and recordation of a lien against the property and its owners if Code Enforcement undertakes the cleanup, often a very expensive proposition. Such liens will encumber the property until the lien is satisfied, often when the property is sold, or the property owner refinances a mortgage loan or seeks a secondary loan.

Low Divide Road, north of the Smith River between Highway 101 and Highway 199, is a long-standing illegal dump location, and is currently the site of eight separate Code Enforcement cases. The wheels of government move

slowly.
Certainly, there are

no shortages of other eyesore properties in the County. For the most part, despite its long history, blight abatement is not a County priority. The Board of Supervisors has been AWOL in prioritizing and addressing the blight problem. The County is losing the battle to contain blight.

physicians break the rules.

In some cases, insurance will not pay for medical treatments a patient needs, but will pay for physician assisted suicide (PAS). It's cheaper.

The statement, "life is cheap",

definitely applies here when one needs medical help, but death is offered as an alternative. The last to receive healthcare with concern and compassion could be the first to be offered and receive physician assisted suicide.

Proponents of PAS would have everyone believe that anybody who ingests their euthanasia pill will quickly and peacefully quit breathing and die. That is not always the case.

It has been documented that after having ingested the life ending

medication, there have been those who have experienced fear, breathlessness, nausea, convulsions, and hallucinations. Not all die quickly.

A friend of mine who was caring for her elderly mother, had some assistance from Hospice. One day, one of the nurses asked the mother if she had considered no longer going on with her life. It was a suggestion to be euthanized. Her response was, "Absolutely not. Don't you know that's against God's will?"

Compassion & Choices, regardless of their name is first and foremost a euthanasia proponent. Triplicate, please don't promote them.

anti-social and law-violating manner.

The City of Crescent also suffers and turns an astigmatic, sight-challenged eye to its blight issues. In the City's case, overgrown weeds permeate from the sidewalks, curbs and four feet into the street. There is Ordinance (8.08.020) to enforce the mitigation of unsightly / overgrown weeds in front of private property but the City fails to address this beautification ordinance. These violations reflect poorly on our community and are in stark contrast to the magnificence

of our area.

- The County and City must enforce existing State littering and trash dumping laws already on the books in the City, County and State.
- The California Highway Patrol, Del Norte County Sheriff's Dept., Dept. of Fish

and Wildlife, and State and National Parks law enforcement officers must step up enforcement by issuing citations for those who litter and foul our environment. If fines are indeed punitive, bad behavior will stop.

• And the most important, vital component for blight abatement is to embrace and recognize volunteer efforts. City and County expression of official appreciation for those those who give of their time, tools and talent which foments more community involvement.

Volunteers from Take a Bite out of Blight, Pride in Community, Smith River Alliance and many independent individual efforts provide enormous support at zero cost to the taxpayer.

I know of one community hero who assumes responsibility in removing unsightly trash from the corner of Washington and Summer Lane, across the street from Walmart. Anonymously, she cleans up the trash, I have seen it several times, and I now commend and recognize this community hero.

Roll up your sleeves and get involved. Volunteer to help clean up this place we all call home.

Sadly, our elected leaders can do much more to bring awareness to discarded couches and other undesirable items that have been abandoned on vacant parcels by irresponsible property owners and tenants who care little about the properties they own or lease, or the neighborhoods in which they live.

When I served on the Board of Supervisors, I spent no shortage of time cruising the streets looking for dumped trash, abandoned vehicles, shopping carts, discarded furniture and fresh graffiti vandalism.

I regret to say that now, in District 1, Supervisor Darrin Short apparently does not share my passion to clean up the district he represents. Without indicating "depraved indifference" associated with Mr. Short or any of the other county supervisors, I feel confident in my statement that addressing this problem is a low priority for the Board of Supervisors.

To its credit, the City has a complaint-driven website which is, nevertheless, painfully slow in addressing long-standing blight issues.

My message to all who care about the appearance of Del Norte County and Crescent City: Do not give up! Continue to file complaints on eyesore properties which offend your good senses. Ignore those who criticize you for caring about how our community looks. Volunteer for the clean-up efforts in your neighborhood and community.

And applaud those who demonstrate their values with action, not empty words.






