# **ID cases surge in Del Norte County**

An Omicron-fueled surge in positive COVID-19 cases swept through Del Norte County this past week - prompting boards, commissions and sports teams to revert to previous safety measures, and resulting in increased hospitalizations.

On Tuesday morning, Public Health Officer Dr. Aaron Stutz reported that there were 159 active cases, though that number increased by late afternoon when the Del Norte Public Health Authority website reported 182 active cases. Hospitalizations of people with symptoms at Sutter Coast Hospital also increased, from two to five.

However, no new deaths were reported and Stutz said the most recent surge could be a sign that the virus - though more contagious, may be losing its previous virulent status.

"The general feeling is that we'll have a large spike in new cases that will rapidly drop, hopefully, after that spike," Stutz said, adding that hospitalizations

and case fatalities will rise, but not "near the same rate that we saw with the Delta variant."

On Tuesday morning, Stutz presented the latest update about COVID infections to the Del Norte County Board of Supervisors. He also said cases had increased by up to 300% compared to the week prior, and those infected were almost evenly split

between the non-vaccinated and "break through" cases of vaccinated individuals.

"We're hoping it won't be enough to overwhelm hospitals," Stutz said. "But unfortunately, it's going to cause a lot of missed work and it's going to cause increased visits to the emergency

# Harbor district tables vote to increase funding to visitor's center

Del Norte County to count the homeless this month

The annual Point-In-Time count that identifies how many homeless people are living in Del Norte County will start January 26.

"This gives us an idea of how many people are living unsheltered and are temporarily sheltered, which affects funding," said Roy Jackson, housing services manager for the Department of Health and Human Services.

In an effort to draw as many people as possible, a take-out meal and other donations will be available to those who show up at Crescent City Recreation Hall, 1005 H Street, from 8 a.m. to 4:30 p.m.

According to Jackson, the survey collects basic information and takes about five minutes to complete. Specifically, respondents will be asked where they slept the night prior on January 25. The U.S. Department of Housing and Urban Development requires communities receiving federal funds from the McKinney-Vento Homeless Assistance Grants program to count those experiencing homelessness. The electronic records also keep track of people who are living in emergency shelters and transitional housing. The unsheltered count is required every two years, though most communities perform the survey each year. "I've been talking with outreach workers, and they feel like the numbers are going to be higher this year," Jackson said. According to the National Alliance to End Homelessness website, those surveyed will also be asked whether they are individually unsheltered, are part of a family unit and whether they or anyone with them are 24 years old or younger. Historically, the latter marker has been difficult to determine because families are reluctant to share that a minor under the age of 18 is with them. Youth living on the streets can also be reluctant to seek out shelters and other community resources. In an effort to reach those who don't go to the recreation hall January 26, several organizations will canvas the county through Feb. 1 to survey as many people as possible. "This will include going to parks, campgrounds and homeless encampments,"

A request from the Del Norte County Visitor's Bureau for an additional \$4,000 from the Crescent City Harbor District failed to receive enough votes that would have increased its marketing budget to \$10,000, and was instead tabled.

The 2-2 tie vote, with one commissioner having recused himself due to a financial conflict of interest, followed a report that showed a \$100,000 increase in room tax revenue compared to the year prior.

Cindy Vosburg, executive director of the visitor's bureau, said they were seeking an increase in funding to capitalize on gains made in new visitor counts and transient occupancy taxes over the past year.

"The more we push out story ideas to travel publications, travel bloggers, etc., the more recognition and media coverage we will receive," Vosburg said.

Lynette Braillard, of Lulish Design, delivered a presentation on behalf of the visitor's bureau prior to the vote.

"The Del Norte County room tax report at the end of quarter four, 2021, was up 413% over the previous quarter," said Braillard. "It was also up 63% over

was pre-pandemic.

Braillard added that the visitor's bureau marketing campaigns also made strides, citing a 157% gain to 217,000 web page views and 69,000 "engagements" - which include comments, likes and shares on social media.


"This current fiscal year, we are doing more influencer marketing," Braillard said, adding that search engine optimization through a partnership with Visit California, as well as a targeted video campaign and software upgrade would also go live this year.

According to Vosburg, the Del Norte County Board of Supervisors recently voted to increase its contribution by \$30,000, for a total of \$114,340, funds of which are allocated as \$92,340 to the visitor bureau and \$22,000 to run the visitor's center.

Crescent City also contributes \$100,000, with \$18,000 being used to pay in-kind utilities and rent, \$72,000 to the visitor bureau and \$11,000 to run the visitor center.

"One of the things that I should point out is that we receive a benefit - via the TOT tax - because of Measure C," said Commissioner Brian

# **Crescent City to move to virtual meetings**

The Crescent City Council passed a resolution that will take council and other city meetings to strictly teleconferencing formats

due to rising COVID numbers, at least for the next 30 days.

During a special meeting on Jan. 7, the council voted to take all actions necessary to conduct meetings of all city boards, commissions and committees in accordance with

the Brown Act, and will revisit the resolution after 30 days.

The provision expressly applies, but is not limited to the Planning Commission, successor agency of the Crescent City Redevelopment Agency, the housing authority and

all other standing committees of the city council.

The City Council has the authority to vote whether to hold its meetings through the use of teleconference, per California Assembly Bill 3.

In 1997, he began working part-time at the Del Norte County Juvenile Hall, covering all shifts and holidays. With great sadness, David resigned from the Hall in November 2021 after 24 years of service due to his health. In the final days of life, David said that he would greatly miss all of his friends from the Hall and that he was sorry to leave them like this.

David and Barbara were married in August of 1980 in Lake Tahoe, CA. They were married for a beautiful 35 years. Barbara passed away in 2015, and almost daily for many years, he would pick wildflowers and take them to her memorial site. Together they had three children, Megan, Mark, and Heather. Barbara already had a daughter named Vanessa, who David loved just as much as one of his own. David was blessed with seven grandchildren. He loved them all so much and would always make sure to be at every sports game, karate ceremony, dance recital, birthday party, or any other family event.

David had a great passion for cycling. For decades, he would ride his bicycle to work every day that he could. He even once ran a full marathon, competing in the 1993 California International Marathon in Sacramento. # A new predator stalks the West

The grizzly bear. The wolf. The cougar. These magnificent creatures, apex predators, how can we not admire them? People cross the world for the opportunity to see one in the wilds of Yellowstone or Alaska.

There, we view them from a distance, free to indulge our awe in safety. It has been a long time since Americans lived in fear of wild beasts.

But now that fear has returned. Fear felt not just in the woods, but also in cities and towns: Paradise, California; Talent, Oregon; and now in suburban Superior and Louisville in Colorado's Boulder County.

The dangerous predator we're facing these days is wildfire, charging even out of grasslands to destroy our very homes. And no one is safe.

pack throughout the West, contributing to "fire weather" like the hurricane-force winds that shockingly bore down on the suburbs of Denver in the dead of winter.

We also made land-management choices that strengthened the threat of fire. First, we behaved as if we could banish fire from we can't eliminate. Far from any forest, this was pushed through tinder-dry grasslands by howling winter winds and burned more than 1,000 suburban homes in a matter of hours. So, like any prey species, we must adapt as best we can. As individuals, we can create defensible

# Guest columns Wind-driven fire ran until the gusts died

The Marshall Fire that demolished more than 1,000 homes along the front range of Colorado two weeks ago was not unique. This particular kind of fire happened before, on April 17, 2018 - 115 miles due south of the Marshall Fire.


The wildfire was simply called the MM 117 fire for mile marker 117 on Interstate 25 south of Colorado Springs, in El Paso County. Despite earning a federal disaster declaration, and scorching over 43,000 acres, it never rated a real name.

Like the Marshall Fire, this grass fire came on fast and stopped almost as soon as the winds died. At the time, it was the fifth-largest in state history but 100 percent contained in 72 hours. It began when a motorist, their car dragging its muffler, sent sparks into the air when there was just 4 percent humidity and winds blowing up to 80 miles per hour.

Sparks ignited the grass. Fire investigators on the scene said any motorist with an overheating engine could have sparked a blaze. The entire day it seemed all of Colorado was hammered by winds that grounded planes at Denver International, then grounded firefighting planes as well.

Unable to reach homeowners by car, with the fire racing away, frantic officials resorted to pleas over Facebook message boards: "A deputy sheriff said he was driving at 35 mph near the fire Tuesday, April 17, 2018, and it was moving faster than he was," reported Wildfire Today.

The final tally was horrifying for a fire that lasted barely the length of a holiday weekend - 24 structures destroyed,

over 43,000 acres scorched, and "untold number of livestock," mostly beef cattle killed, according to the Colorado Springs Gazette.

Speed was a big part of the story. The fire raced due east and covered 20 miles in just a few hours. Along the way, It leaped over roads, torched houses and seemed impossible to stop. Yet when winds died and rains came, containment of the fire happened quickly.

There is a stunning lesson to be learned from this grassland fire: We have little control over wind-whipped grasslands fires once they get going. All we can do is run.

As an ecologist, I know that predators are essential to the health of wildlife communities, keeping prey populations in check. They're also a driving force in evolution, favoring the faster or stronger or smarter animals able to escape their attacks. Of course, civilization long ago freed us from the evolutionary pressure exerted by predators. But that freedom has come at a cost.

When populations and ecosystems grow badly out of balance, there must come a correction. Humans and the environments we have created are not immune to this rule, and we must recognize that we have unleashed the firepredator through our own choices.

What choices? On the global scale, we have released vast amounts of carbon dioxide and other greenhouse gases into the atmosphere. This was done at first in ignorance, but for at least the past 30 years, it truly was a choice made in the face of increasingly desperate warnings.

The resulting greenhouse effect has raised temperatures and decreased rain and snowthe landscape, suppressing all wildland fires everywhere, and ending the use of prescribed fire in forests as a management tool. This led to a huge build-up of flammable fuels.

Second, industrial-scale logging eliminated over 90% of fire-resistant old-growth forests and replaced them with highly flammable tree plantations. Finally, we vastly expanded our human footprint, building houses right where the fire-predator likes to roam, at the brink of forests and grasslands.

Reconciling ourselves to the depredations of wildfire requires that we take the long view – the really long view. The fuel-choked forests resulting from our (mis)management need to burn, and they will burn. The best we can do is to preserve the old forests that remain and manage younger forests to increase their resilience to moderate-intensity fire. It could be a century or more before a new forestland equilibrium is reached, one with lower fuel loads, better adapted to the high fire-frequency climate we have created.

Meanwhile, what about us? Colorado's Marshall Fire proved that wildfire is the one predator space around our homes. We can get skilled at escaping wildfire by having evacuation plans ready.

As a society, we can adopt sensible policies to limit sprawling development in fire-prone areas. Recent events prove that these include not just remote forestlands, but even grasslands near suburbs. Faced with predators, animals try to get into the center of the herd. We need to do the same, avoiding exposure to the fire-predator at the vulnerable edge.

Finally, we can — we must — embark on an urgent global effort to end the burning of fossil fuels within the next few decades. If we do not, the West will face year-round fire weather, and a future at the mercy of fire.

Yet there is reason for hope: the uniquely human capacity for rapid social and cultural evolution. Let's harness that strength, and work toward the day when fire is a predator no more, but our powerful partner in the stewardship of the land.

Stone, immediately after Braillard's presentation. Measure C passed in 2018, and raised the TOT tax from 8% to 10%.

These applications have been used in assisting with conservation efforts with condors, wolves, sea otters, dolphins, sea lions, polar bears, sea turtles, chimpanzees, elephants and many others. Ramirez is the executive vice-president and chief training officer of Karen Pryor Clicker Training where he oversees the vision, development, and implementation of training education programs for the organization. He also runs the KPCT National Training Center where he teaches courses and seminars year-round. Previously, Ken served as EVP of animal care and animal training at Chicago's Shedd Aquarium, where he developed and supervised animal care and animal health programs, staff training and development as well as public presentation programs for more than 32,000 animals. He worked at Shedd

A 40+ year veteran of animal care and training, Ramirez is a biologist and animal behaviorist who has overseen or consulted on training projects for many zoological organizations worldwide. # Lawsuit aims to protect Pacific Humpbacks from deadly fishing gear

The Center for Biological Diversity sued the National Marine Fisheries Service today for failing to protect endangered Pacific humpback whales from deadly entanglements in sablefish pot gear off the coasts of California, Oregon and Washington.

Today's lawsuit challenges the federal permit given to the fishery in December to kill and injure endangered humpback whales without any changes to avoid harming whales. Fishing gear entanglements are a leading threat to endangered humpbacks that migrate along the West Coast, where 48,521 square nautical miles were designated as critical habitat in April.

"These migrating whales shouldn't have to dodge deadly commercial fishing gear, especially in national marine sanctuaries," said Catherine Kilduff, a center attorney. "This is critical habitat for endangered humpbacks, but it's full of long

strings of fishing pots. It's outrageous that the Fisheries Service rubber-stamped the status quo despite growing threats to these whales. Humpbacks are our magnificent, acrobatic neighbors, and we need to stop the increasing deaths in commercial fishing gear."

As climate change alters migration patterns and availability of food for whales, it's harder for

endangered humpbacks to avoid commercial fishing gear. Until last month, the West Coast fisheries for the bottom-dwelling sablefish — also known as butterfish or black cod — had operated for five years without authorization to take whales under the Endangered Species Act and Marine Mammal Protection Act.

According to Fisheries Service estimates, the

sablefish fishery on average kills or seriously injures about two humpback whales every year. The fishery uses 2-mile-long strings of 30 to 50 pots. Commercial fisheries in total entangle 25 humpback whales annually off the U.S. West Coast; more than half of the entanglements are not identified as being tied to a specific fishery.

The lawsuit, filed in U.S. District Court in Northern California, focuses on several deficiencies in the Fisheries Service's analyses of the sablefish fishery's impact. These include outdated humpback whale stock assessments, the failure to recognize the smallest humpback population — that winters in Central America — as distinct, and the failure to consider the Fisheries Service's own analyses of the growing whale entanglement threat.

The Service found a 400% increase in humpback mortality and serious injury from human activities, in-

cluding vessel strikes, since 2018 estimates. This year marks the 50th anniversary of the Marine Mammal Protection Act, a landmark law that recognized the "great international significance" of marine mammals, including their esthetic, recreational and economic importance. The law prohibits harming marine mammals except under specific circumstances. Commercial fisheries that occasionally or frequently kill or seriously injure endangered marine mammals must have only a negligible impact on the species or stock to get an incidental take permit.

To make fishing safer for whales and other imperiled animals, the Center proposed last month that the Fisheries Service require all fisheries that use pot gear to covert to new ropeless or "pop-up" gear within in the next five years. The petition requests that the agency prioritize the transition in national marine sanctuaries.

Most trap and pot fisheries use static vertical lines that can wrap around whales' mouths, fins or tails, depleting their energy and drowning them as they drag the heavy traps. Pop-up traps use lift bags or buoys on coiled ropes triggered by remote or time-release sensors to float the traps to the surface, eliminating those static entangling lines.



College of the Redwoods trustees voted to approve a new Education Master Plan at their January meeting. Erin Wall, president of CR's Academic Senate, expressed appreciation for the inclusive nature of the process, stating, "The Senate appreciated the chance to engage faculty broadly across the district in reviewing and discussing the draft that came out at the end of the summer. We are all looking forward to moving forward under this new educational master plan."

The meetings produced the following themes that emerged with regard to the educational opportunities the college should pursue in the future to strengthen regional workforce and to better align with community needs:

Prioritize learning opportunities deeply rooted in Humboldt County's unique natural, cultural, and economic ecosystem.

Expand hands-on, experiential, and project-based learning that embraces interdisciplinary collaboration amongst faculty, students, and community partners.

Strengthen partnerships with local industry, government, nonprofits, and tribal communities to support the above activities - including internships, apprenticeships, and mentoring.

Prioritize activities that lead to living wage jobs in our community and continue to strengthen the HSU / CR partnership.

"A brave community of College of the Redwoods dreamers embarked on a long collaborative and inclusive process to develop a new Education Master Plan that will guide our path forward," said CR President Keith Flamer. "As president, I had the pleasure of working with several faculty who committed themselves to thoughtfully framing a critical plan that represents the shared goals of our community. I want to express my gratitude to the Education Master Plan Guiding Coalition,

Professor Chris Gaines, and the College of the Redwoods Board of Trustees for their commitment and support throughout this process."


