COUNT 1

The Grand Jurors of Coffee County, Tennessee, duly impaneled and sworn upon their oath present that **Kurt Eldon Glick**, in Coffee County, Tennessee, and before the finding of this indictment, unlawfully, knowingly and feloniously did commit an offense, while being a public servant, said **Kurt Eldon Glick** being an employee for the City of Tullahoma, TN, said offense committed with intent to obtain a benefit or to harm another, by committing an act relating to the public servant's office or employment that constitutes an unauthorized exercise of official power, in violation of T.C.A. 39-16-402(a)(1) and against the peace and dignity of the State of Tennessee.

COUNT 2

The Grand Jurors of Coffee County, Tennessee, duly impaneled and sworn upon their oath present that **Kurt Eldon Glick**, in Coffee County, Tennessee, and before the finding of this indictment, unlawfully, knowingly and feloniously did commit an offense, while being a public servant, said **Kurt Eldon Glick**, being an alderman for the City of Tullahoma, TN, said offense committed with intent to obtain a benefit or to harm another, by refraining to perform a duty that is imposed by law or that is clearly inherent in the nature of the public servant's office or employment, in violation of T.C.A. 39-16-402(a)(3) and against the peace and dignity of the State of Tennessee.
