Defendant's motion to suspend sentence
pursuant to N.H. RSA 651:20

Now comes the defendant Nathan E. Cashman prose, and respectfully requests this honorable court suspend the defendant's minimum sentence pursuant to N.H. RSA 651:20. Support for request as follows:

1) On 8/13/2015 the defendant entered a negotiated plea to include the following: 10-20 years for Enhanced Reckless Conduct with a deadly weapon, 3½ to 7 years for Possession of Methamphetamine, 3½ to 7 years for Reckless Conduct, and 12-months in the House of Corrections for Resisting Arrest, all sentences are concurrent with one another.

2) The defendant was given the option to receive 1-year off his minimum sentence for completion of the FOCUS program. The defendant completed the FOCUS program in 2018.

3) The defendant was also given the option to receive Earned Time Credits (pursuant to RSA 651:25) in order to reduce his sentence. The defendant completed all recommended Mental Health programs and received (60 days) off for it. Also, the defendant completed the "CHI" courses and received (60 days) off for them.

4) The defendant recognizes the severity of his actions, the negative effects they had on the community and because of this has changed his life, and way of thinking so when he is released he can be a positive and productive member of society.

5) The defendant has made significant changes from who he was to who he is now and has engaged in the following Rehabilitative Efforts: the defendant graduated from Granite State High School in March 2021, has completed all recommended Mental Health programs, has completed the FOCUS program, has participated in 8 semesters in Automotive Shop, has had a job in the kitchen for approximately two years, has completed several Career Technical classes, has had no dirty urine analysis, has only two tickets on Disciplinary report list that have not been worked off, and continually sees mental health for the disorders of Stimulant Induced Psychotic Disorder, Depression, Anxiety, and ADHD. Other disciplinary tickets than the two mentioned are from previous sentence.

⑥ The defendant is currently on the waiting list for the Thinking for a Change program.

⑦ The defendant has a strong support system which he maintains contact regularly with including his Mother, Brothers and Grandparents along with multiple friends who are prepared to assist the defendant with his re-integration back into society.

Wherefore, the defendant requests this honorable court to: suspend his minimum sentence pursuant to N.H. RSA 651:20 or alternatively schedule a hearing on this motion.
