Affidavit in Support of Arrest Warrant

I, Detective Andrew Sheffer of the New Hampshire State Police, being duly sworn depose and say under oath that:

1. I, Detective Andrew Sheffer, am a full-time certified Police Officer. I have been employed by the New Hampshire State Police for 11 years and 11 months, and I am currently assigned to the Major Crime Unit. Prior to my assignment in the Major Crime Unit, I worked in the Troop B Detectives Office in some capacity for 3 years. Prior to my assignment in the Troop B Detectives Office, I worked as a Patrol Trooper in both Troop B and Troop E. I am a graduate of the 158th NH Police Standards and Training Council Academy, and in addition to the training and education that I received at the Academy in New Hampshire's criminal law and investigative techniques, I have received continued education and training to go along with my experience over the last 11+ years.
2. The information set forth below is based primarily upon my personal involvement in the investigation into alleged domestic violence occurring between Michael MACNEILLY ([REDACTED]) and [REDACTED], and partially upon work done by other Law Enforcement Officers involved in the investigation.
3. M. MACNEILLY was, at the time of the alleged incidents, a full-time certified Police Officer employed by the Manchester Police Department.
4. On 10/17/2023 at approximately 1948 hours, M. MACNEILLY called another Officer at Manchester PD (Max Duffield) who was on-duty at the time. M. MACNEILLY told Ofc. Duffield [REDACTED]
