Kayla Montgomery holds an account with the New Hampshire Department of Health & Human Services, Division of Family Assistance. The case number assigned to Kayla's account is: XXXXX2376. On 2/25/2019, Kayla filed a "Change Report" with NH DHHS indicating the reason for the change as: "My husband, Adam Montgomery's daughter, HM is now currently living with us full-time. She is 4 years old and permanently blind in one eye, she was born like that. any questions or concerns please call 603-XXX-XXXX-cell. Thank you." New household member added to the account was "HRM" DOB 06/07/2014. Kayla Montgomery electronically signed this document. The DHHS file indicates that the benefits alloted to the Montgomery family (account 717372376) increased by \$129.00 per month, beginning on 3/1/2019, upon adding HM to the account. This does not include additional COVID supplemental benefits. According to the Lawrence (MA) Juvenile Court, HR's father, Adam Montgomery DOB 1/22/90, was granted full custody of HM as of 2/22/2019.

On 1/7/2021, as part a redetermination process, Kayla indicated to the DHHS that her household consisted of "2 adults married filing jointly, 4 children - 3 in common and all claimed as tax dependents." Adam and Kayla Montgomery have three children in common: SM DOB 6/8/17, CM DOB 11/4/20 and DM DOB 1/30/19. The DHHS case worker added a note on the redetermination paperwork of: "she [Kayla] seemed confused about whether or not Harmony lived there because goes to her mom's every other weekend."

On 6/2/21, another account change report was initiated regarding Kayla's income. During that contact, DHHS noted that case management for HM was closed, noting "client said she moved back with her mother and to remove her from her case."

Recently, the Manchester Police Department became involved in an investigation into the possibility that HM is a missing person. HM's mother was identified as: Crystal Sorey DOB 9/14/90. DCYF and the Manchester Police Department had spoken with Crystal on several occasions and she reported that she has not seen Harmony in over two years, and that she had been trying to locate her to obtain visitation.

Recently, Manchester Police Officers located Adam and inquired about the whereabouts of HM. Adam was insistent that he returned HM to Crystal in November of 2019 and hadn't seen HM since. Manchester Police Department traveled to Devens, MA to interview Crystal in person and confirmed that HM was not with her or under her care. These circumstances resulted in a full scale missing child investigation for HM. Part of this investigation included an interview with Kayla. Kayla stated that on the day after Thanksgiving in 2019, Adam dropped her off at work and said he was going to bring HM to her mother to live with her. Kayla stated that she has not seen HM since that day. When asked about receiving food stamp assistance for HM for over a year after that time, Kayla acknowledged receiving those benefits knowingly, and indicated that she attempted to remove HM from the account but was unsuccessful. According to the case management documents I have received and reviewed from NH DHHS, Kayla did not make any request or attempt to remove HM from her household account until 6/2/21 (as noted above).

On 1/3/22, A subpoena was served to the Supplemental Nutrition Assistance Program of the Bureau of Family Assistance of NH DHHS, in order to obtain records of benefits related to HM. With HM being a household member of Kayla's account, and thus benefits being paid for HM, these benefits were distributed and recorded under Kayla's account. The DHHS Office of Finance provided the EBT transaction history of Kayla Montgomery's EBT card. This report included all transactions between February of 2019 and June of 2021. There are 22 pages of transactions, with an estimate of approximately 800 transactions. The pattern shows that Kayla was receiving benefits and then spending them and depleting the balance perpetually.

Based on Kayla and Adam's statements regarding last seeing HM in November of 2019, both Kayla and Adam stating that HM was returned to Crystal Sorey in November of 2019, and the fact that food stamp benefits for HM were being paid to Kayla Montgomery until June of 2021, it is estimated that Kayla received in excess of \$1500 in benefits that she was not entitled to as HM was not under her care. This amount does not include any of the COVID supplemental benefits that were paid from December of 2020 to present. This total includes \$129 paid for the following months: 12/2019, 1/2020, 2/2020, 3/2020, 4/2020, 5/2020, 6/2020, 7/2020, 8/2020, 9/2020, 10/2020, 11/2020, 12/2020, 1/2021, 2/2021, 3/2021, 4/2021, 5/2021, 6/2021.

NH RSA 167:17-b Prohibited Acts states that no person shall intentionally fail to disclose the receipt of property, wages, income or resources or any change in circumstances which would affect his eligibility for assistance or his initial or continued right to any benefit or payment for the purpose of receiving any assistance, benefit or payment to which he is not entitled. NH RSA 167:17-c states that any natural person who violates NH RSA 167:17-b shall be guilty of a class A felony if the value of the monetary award or goods or services in question exceeds \$1,500.
