In the past, Richard has informed [REDACTED] of previous acts of violence in his past related to criminal organizations. On Sept 8, 2021, Richard texted [REDACTED] "My friend from RI says hi. Remember that guy that did you that favor" in reference to a man who R told L had broken the jaw of another man who was blackmailing L to do sexual acts. Richard reorganized his guns in front of L while angry to intimidate while angry on Friday August 27th.

Additional Space for Statement of Facts

In the past, Richard has been sexually violent and coercive. Sex is used as punishment, including unwanted anal intercourse, smothering covering both mouth and nose, hitting private parts, using language of rape, slavery, and control. This behaviour coincides with anger over actions of [REDACTED] like staying over friends houses. This sexually violent behaviour has continued for years. Further in the past, Richard has coerced [REDACTED] into sexual situations with unsavory old men chosen specifically as undesirable as form of punishment.

When Richard learned on Labor Day, 2021 that [REDACTED] had rented a room at her yacht club the week before as he searched through her emails, he tracked her on her cell phone to Marblehead, MA. L agreed to meet R at Marblehead lighthouse in a public place as his texts read "I will make you pay." At the public park, Richard yelled profanities at [REDACTED] calling her a "C%*t." He continued screaming, "I am going to f*** you up. I am going to f*** up your whole life. Everything you hold dear, I will f*** it up. You can't trust anything to be okay anymore. I am going to turn your world upside down. You'll see. You'll pay. You chose this." This caused immediate fear and [REDACTED] did not return to the home she owns at [REDACTED] and had been cohabitating with Richard. It seemed a resolution was in place that Richard would remain in the home and [REDACTED] staying with friends and family until November, when Richard would be complete a course and able to get a job. However, Richard blackmailed [REDACTED] to talk to him on Wednesday September 15th at 6pm. [REDACTED] agreed, but when the day came felt it was too scary to go back to the house given reports from her tenant, [REDACTED] about Richard's behavior. [REDACTED] went with a friend to the police, who recommended filing for a restraining order at the court. [REDACTED] texted [REDACTED] while she was still at the police stay that Richard had left with one of the dogs at 6:15. [REDACTED] felt it safe enough to grab some personal items from the home. However, Richard returned to the home soon after. He gave her a final ultimatum, "You be my sex slave Thursday to Sunday and this can all be over." [REDACTED] declined the offer and in the meantime, Richard's anger was apparent and her friend had a peace officer come by. The officer directed Richard to return house keys and he left. Upon inspection of the home, it became obvious that Richard had stolen large ticket items that were purchased with [REDACTED]'s credit cards like a generator and a snow blower. Other missing items included [REDACTED]'s motorcycle keys, all the remotes, [REDACTED]'s mental health medications, [REDACTED]'s motorcycle gear like leather jackets and pants, etc. A full inventory was not completed as [REDACTED] did not want to stay in the home long while Richard was in anger and at large. Immediately after this, Richard started texting and calling [REDACTED]'s family, employers, and friends in nearly daily harassment as a first step to make [REDACTED] pay. Future consequences are unknown, but his behavior seems to be escalating. [REDACTED]'s family and therapist a very concerned that he will resort to violence in this revengeful mindset where he has lost control. Richard has previously attempted suicide by combining medications, resulting in a coma, so he has demonstrated an attitude of "nothing to lose" with a disregard for consequences.
