THE GRAND JURY, for the County of Victoria, State of Texas, duly selected, empaneled, sworn, charged and organized as such at the July term, A.D., 2019 of the 377TH Judicial District Court for said County, upon their oaths present in and to said Court at said term, and before the presentment of this indictment, that

COUNT 1 - SEXUAL ASSAULT
§22.011(a)(1) PC/SECOND DEGREE FELONY

On or about the 1st day of December, A.D., 2009 through on or about the 31st day of March, A.D., 2018, in the County of Victoria and State of Texas, one JESSE GARZA, did then and there coerce, Joe Thomas, a pseudonym, to submit and participate, and Jesse Garza intentionally and knowingly caused the [REDACTED] of Joe Thomas by any means, including [REDACTED] of Jesse Garza without the consent of Joe Thomas...

COUNT 2 - SEXUAL ASSAULT
§22.011(a)(1) PC/SECOND DEGREE FELONY

On or about the 1st day of December, A.D., 2009 through on or about the 31st day of March, A.D., 2018, in the County of Victoria and State of Texas, one JESSE GARZA, did then and there coerce, Joe Thomas, a pseudonym, to submit and participate, and Jesse Garza intentionally and knowingly caused the [REDACTED] of Joe Thomas with [REDACTED] of Jesse Garza without the consent of Joe Thomas...

COUNT 3 - SEXUAL ASSAULT
§22.011(a)(1) PC/SECOND DEGREE FELONY

On or about the 1st day of December, A.D., 2009 through on or about the 31st day of March, A.D., 2018, in the County of Victoria and State of Texas, one JESSE GARZA, did then and there coerce, Joe Thomas, a pseudonym, to submit and participate, and Jesse Garza intentionally and knowingly caused the [REDACTED] of Joe Thomas, a pseudonym, to [REDACTED] of Jesse Garza without the consent of Joe Thomas...

COUNT 4 - THEFT FROM PERSON
§31.03 (e)(4)(B) PC/ STATE JAIL FELONY

On or about the 1st day of December, A.D., 2016 through on or about the 31st day of March, A.D., 2018, in the County of Victoria and State of Texas, one JESSE GARZA, did then and there unlawfully appropriate property, by acquiring or otherwise exercising control over property other than real property, to wit: U.S. Currency, of the value of \$2,500 or more but less than \$30,000, without the effective consent of the owner, Joe Thomas, a pseudonym, with intent to deprive said owner of said property...

COUNT 5 - OBSTRUCTION OR RETALIATION
§36.06(c) PC/ THIRD DEGREE FELONY

On or about the 1st day of December, A.D., 2016 through on or about the 31st day of March, A.D., 2018, in the County of Victoria and State of Texas, one JESSE GARZA, did then and there intentionally and knowingly threaten to harm another, to-wit: Joe Thomas, a pseudonym, by an unlawful act, to-wit: distributing pornographic images of Joe Thomas, without the permission of Joe Thomas, in retaliation for or on account of the status of Joe Thomas as a witness or a prospective witness or a person who has reported or who Jesse Garza knew intended to report the occurrence of a crime, to-wit: official oppression and sexual assault...

COUNT 6 - PUBLISH/THREAT TO PUBLISH INTIMATE VISUAL MATR
§21.16 PC/STATE JAIL FELONY

On or about the 1st day of January, A.D., 2017 through on or about the 25th of October, A.D., 2017, in the County of Victoria and State of Texas, one JESSE GARZA, did then and there intentionally disclose visual material depicting Joe Thomas, a pseudonym, with the Joe Thomas's intimate parts exposed or engaging in sexual conduct, and the visual material was obtained or created under circumstances in which the Joe Thomas had a reasonable expectation that the visual material would remain private, and the disclosure of the visual material caused harm to the depicted person, to-wit: subjected Joe Thomas to ridicule or embarrassment, and the visual material revealed the identity of Joe Thomas...

COUNT 7 - HARASSMENT
§42.07(c) PC/CLASS B MISDEMEANOR

On or about the 1st day of December, A.D., 2017 through on or about the 31st of March, A.D., 2018, in the County of Victoria and State of Texas, one JESSE GARZA, did then and there with intent to harass, annoy, alarm, abuse, torment or embarrass Joe Thomas, a pseudonym, send repeated electronic communications in a manner reasonably likely to harass, annoy, alarm, abuse, torment, embarrass or offend...

COUNT 8 – OFFICIAL OPPRESSION
§39.033(d) PC/CLASS A MISDEMEANOR

On or about the 1st day of December, A.D., 2017 through on or about the 31st of March, A.D., 2018, in the County of Victoria and State of Texas, one JESSE GARZA, a public servant acting under color of his office or employment did then and there intentionally subjected Joe Thomas, a pseudonym, to sexual harassment, to-wit: make unwanted sexual advances and unwanted sexual contact...
