the sheetrock wall of her son's apartment and the employee made the repairs during the course of his work day with the county and used county material to make such repair. Sheriff O'CONNER stated the Victoria County Auditor, Judy MCADAMS, had informed him she heard the report also and was going to review the purchases made by the county maintenance department.

- 2.2 On Tuesday, 11-09-2010 at approximately 1:00 p.m., Ranger PILKINGTON met with County Auditor MCADAMS. County Auditor MCADAMS stated she had heard the report of Joyce DEAN misusing county funds and looked through all the purchases by county maintenance employees. County Auditor MCADAMS stated she identified two purchases which identified materials used in the repair of sheetrock. County Auditor MCADAMS provided Ranger PILKINGTON with Zarsky Lumber Company Invoice number 006-758846 (Exhibit 2.1) which identified the purchase of a putty knife, drywall tape, joint compound, caulk, and a caulk gun. These items were purchased on 10-12-2010 and charged to the County Health Department. County Auditor MCADAMS also provided Ranger PILKINGTON with Lowe's Invoice number 38921 (Exhibit 2.2) which identified the purchase of wallboard joint compound, wall patch repair, drywall tape, and sanding sponge. These items were purchased on 07-01-2010 and charged to the County Health Department. County Auditor MCADAMS stated she did not know who made both of these purchases; but, she stated both purchases were ultimately approved by the county maintenance supervisor, Dale LESIKAR.
- 2.3 On Wednesday, 11-09-2010, at approximately 2:30 p.m., Ranger PILKINGTON met with LESIKAR at the Victoria County Maintenance Office. Ranger PILKINGTON interviewed LESIKAR and obtained a sworn written statement (Exhibit 2.3) from him. The following is LESIKAR'S statement:
- 2.4 "My name is Dale Edward Lesikar, I am of sound mind, over 18 years of age, and competent to give this affidavit. I am currently employed by the County of Victoria, Texas. and have been since March 1992. I am giving this statement to Texas Ranger Drew E. Pilkington. I am giving this statement freely and voluntarily, and no threats or promises have been made to me."

25 LESIKAR'S statement continued: "At or about 3 months ago I was in my employee office at the old fire station at 209 Forrest St. at 8:00 am visiting with my Asst. employee David Banda about starting the day off. While in conversation with David, he asked if I had talked with Earnest Dominquez at the Health Dept. (Earnest is one of my employees taking care of maintenance at the health Dept.) I told David that I have not seen him for a couple of days, but plan to today. David told me Earnest told him about some repairs he did and he (David) told me to ask him (Ernest) about repairing sheetrock for Joyce at Her son's (Robert's) house or apartment. I asked what he was talking about, he (David) said he (Earnest) was asked to do some damage repairs before the landlord saw it. Latter that morning, I went to the health Dept. as I usually do several times a week. When I saw Earnest, I asked him what it was that David told me about. Earnest told me that he was called by Joyce Dean to do her a favor and repair some sheetrock that was broken out when her son fell through it. I asked if this was done during working hours, Earnest said yes but it did not take long. I then remembered while signing invoices several days earlier that some sheetrock tape and mud had been on one of the bills that I signed, the items were purchased with Earnest's Signature and I think the invoice was from Zarsky' I asked Earnest if this was some materials that he had used on this job and he told me it was, Earnest also told me he had used a piece of sheetrock which was upstairs at the health Dept., that piece of sheet was left over from a previous job and I assume because it was on county property it had been purchased with county funds but I don't know when it was purchased. I informed Earnest that he should have called me before he did this, because I would have instructed him to do this on his own time and own materials. He told me that she (Joyce) called him and got him to do it and he asked what was he supposed to do. I told him that I was his supervisor and should have been made

aware of it then."

- 26 LESIKAR'S statement continued: "After this meeting we went back to work and did not talk of it any more. On the week of Nov. 1st, I was contacted by Joyce about this and she asked if I had heard the rumors of this repair. I told her that I did hear them going around the courthouse, but was not concerned with them because rumors float all the time. I told her that any employee can do any side work they want to if they are on their own time. She agreed with me and said that this was done on off hours and she told me the rumor was she was being investigated over this and she told me she was not being investigated over this. I left the conversation alone at that. The reason that I never said anything of this to my supervisors is the fact it was at election time, and the mood of all those involved with the elections would have not made it comfortable for me and I didn't want to worsen the mood. Joyce has the same supervision as I do and they depend on her very much. I did not feel it would go well if I said anything about this to them and would make un-easy working conditions for me if I did say anything."
- 2.7 At approximately 3:26 p.m. on 11-09-2010, LESIKAR signed the sworn statement (Exhibit 2.3) and the interview was concluded.
- 2.8 On Wednesday, 11-09-2010, at approximately 3:30 p.m., Ranger PILKINGTON met with David BANDA at the Victoria County Maintenance Office. Ranger PILKINGTON interviewed BANDA and obtained a sworn written statement (Exhibit 2.4) from him. The following is BANDA'S statement:
- 2.9 "My name is David Banda, I am of sound mind, over 18 years of age, and competent to give this affidavit. I am currently employed by the County of Victoria, Texas. My office telephone number is 361-575-2762. I am employed as the Assistant Maintenance Supervisor with the County of Victoria, and have been for one year, I've worked for the County of Victoria for about fifteen years. I am giving this statement to Texas Ranger Drew E. Pilkington. I am

- 2.10 BANDA'S statement continued: "Sometime, I think in July, Earnest Dominguez came up to me, when I was at the Health Department Building picking up some receipts, and he told me he was doing stuff for Joyce Dean. Earnest told me he was doing personal work for her while on county time, he said sheet rock, tape and float, and drive her son around. Earnest said he was tired of driving her son (Robert Dean) around in the County truck while he was on duty. Earnest said he would drive Robert around to pay bills, take him to the probation office, and do other personal business because Joyce told him to do so. Earnest said Joyce would call him and tell him to go and pick up Robert and to do stuff for Earnest said one day Joyce called him and told him she needed him to fix some stuff at a house. Earnest said he went over there and cut out a piece of sheet rock and replaced it and then taped and floated it. Earnest didn't say whose house it was, he just said it was for her (Joyce). Earnest didn't say where he got the materials from, but he told me he went to the house in the County truck and he said every time he did something for Joyce or Robert, it was in the County truck. Earnest told me he did not want to do this stuff anymore and he tired of doing these things because he was scared of getting in trouble for doing it because he knew it was wrong, but he said he was doing it because Joyce was the boss and he was scared if he didn't do it for her, she would fire him."
- 2.11 BANDA'S statement continued: "A little while after Earnest told me, like a month or so, I told my boss Dale Lesikar about this. Dale got mad and then said he would take care of it."
- 2.12 At approximately 3:58 p.m. on 11-09-2010, BANDA signed the sworn statement (Exhibit 2.4) and the interview was concluded.

Ranger PILKINGTON obtained a sworn written statement (Exhibit 3.1) from DOMINGUEZ and the following is his statement:
  - 3.2 "My name is Earnest Victor Dominguez, I am of sound mind, over 18 years of age, and competent to give this affidavit. I am currently employed by the County of Victoria, Texas. My office telephone number is 361-573-3951. I am employed as a Maintenance Person with County of Victoria and have been for 3 ½ years. I am giving this statement to Texas Ranger Drew E. Pilkington. I am giving this statement freely and voluntarily, and no threats or promises have been made to me."
  - 3.3 DOMINGUEZ'S statement continued: "Approximately one year ago or eleven months ago, Joyce Dean called me and she asked me if I could help Robert Dean out with repairing some damage in a wall at his (Robert's) apartment. The apartment was behind HEB on North Street. I told her I would do it after work. I was in the area filling up with gas at the county gas pump on North Street and so I stopped by to see what type of damage was done so they could get the materials to get it fixed. I went to the apartment with Robert in the County truck and looked at the damage which was hole in the wall in the living room. It looked like they were wrestling and someone had gone through the wall. I told Robert I needed a 3x5 piece of sheet rock and mud and tape and screws to screw it in. After I looked at the apartment, I came back to work. Later that same day after I got off of work at 3:30 p.m. I went home and then went to Robert's apartment around 6:00 p.m. and I fixed the sheet rock. used my own tools to fix the sheet rock and it only took me about an hour and a half to do it, it was very simple I just cut from stud to stud and cut the new piece and then screwed it in. Robert's father Mark Dean was there while I worked, Robert was still at work and he (Robert) showed up after he got off work. When I got to the apartment the sheet rock,

the mud, and the tape was already there in the apartment. I did not paint the piece and I do not know who painted it. I did this work as a favor to Robert, I knew he was having a hard time and I was just helping him out. About a week later, Robert came into the office and gave me a twenty-dollar bill for me helping him out. He gave me the money for helping him out, I went and bought some tacos for us with the money."

- 3.4 DOMINGUEZ' statement continued: "In other times, I would drive Robert to the probation office to pay his money, this was on the first of the month and lasted for about three months. Robert would have to pay the probation office and Kathy Stewart. I only took him to the courthouse and back. A couple of times I would drive him to his dad's shop on John Stockbauer and then bring him back. I was doing this because of Joyce, I told my boss, Dale Lesikar, every time to let him know what I was doing and I was hoping he (Dale) could put a stop to all this. I wanted Dale to put a stop to this because I knew it was wrong and I was doing it on County time and in the County truck. I knew it was wrong but I was doing it because Joyce wanted me to drive him there or Robert would tell me his mom wanted me to take him there. Robert didn't have a driver's license and I wouldn't let him use the County truck. Joyce has not called me or talked to me about this. I saw her at a meeting last week at the courthouse about insurance. I talked to her at the meeting about insurance and the retirement but she did not talk to me about this incident. On November 1st Joyce called and left a message with Roger Suniga at the office and I called her back from my house she said she was sorry I was involved in all this. Joyce was crying and she said she was sorry I was involved in all this and for people talking about all this. She never said what 'this' was and just said people in the courthouse were talking about me. Joyce said she was crying because her son was going away to Dallas or something so I assume that is what she was crying about."
- 3.5 DOMINGUEZ'S statement continued: "Joyce has never talked to me about the sheet rock repair incident since she initially called and asked me to help Robert. Joyce has never told me
