In each case, the Commissioners are responsible for independently reviewing the application and full record, weighing the evidence, and coming to a decision that complies with state law.

Background on Docket 6680-UR-125

- On March 31, 2025, Alliant Energy filed an application to adjust electric and natural gas rates in 2026 and 2027.
- On September 3, 2025, Alliant Energy filed an application seeking approval of a full settlement agreement supported by all parties.
 - o Parties include Blacks for Political and Social Action of Dane County, Inc. (BPSA); Clean Wisconsin; Citizens Utility Board of Wisconsin (CUB); International Brotherhood of Electrical Workers Local 965 (IBEW); RENEW Wisconsin (RENEW); Walmart Inc. (Walmart); and Wisconsin Industrial Energy Group (WIEG).
- For additional details about the application, consider contacting the applicant and/or parties directly.
- The PSC held a public hearing on September 9, 2025 and accepted public comments
 relating to this proposal from August 8 to September 11 to gather public input about the
 proposal.
- During the open meeting, the Commission approved in whole (with standard order conditions) the Settlement Agreement.
- Commission approval of the settlement results in a \$57.8 million decrease in the utility's initial retail electric revenue request and a \$1.5 million decrease in the utility's initial retail gas revenue request.
- Bill estimates include:
 - The average electric residential Alliant Energy customer with an expected energy usage of 650 kilowatt-hours per month can expect a \$9.57 monthly increase (8.22% increase) beginning in 2026 as compared to currently authorized rates.
 - The average electric residential Alliant Energy customer with an expected energy usage of 650 kilowatt-hours per month can expect a \$17.45 monthly increase

(14.98% increase) beginning in 2027 as compared to currently authorized rates. This represents the full increase over the next two years.

- The average residential gas Alliant Energy customer with an expected energy usage of 751 therms per month can expect a \$1.08 monthly increase (3.01% increase) beginning in 2026 as compared to currently authorized rates.
- The average residential gas Alliant customer with an expected energy usage of 751 therms per month can expect a \$1.80 monthly increase (5.00% increase) beginning in 2027 as compared to currently authorized rates. This represents the full increase over the next two years.

- Xcel Energy filed an application to adjust electric and natural gas rates in 2026 and 2027.

- The PSC held a public hearing on September 11, 2025 and accepted public comments relating to this proposal from August 8 to September 15 to gather public input about the proposal.
- Commission action results in a cumulative \$24.6 million decrease in the utility's initial Wisconsin retail electric revenue request and \$2.2 million decrease in the utility's initial Wisconsin retail gas revenue request.
- Bill estimates include:
 - o The average residential Xcel Energy customer with an expected energy usage of 698 kilowatt-hours per month can expect a \$13.47 increase on their monthly electric bill due to increased base rates beginning January 1, 2026.
 - o The average residential Xcel Energy customer with an expected energy usage of 698 kilowatt-hours per month can expect a \$24.91 increase on their monthly electric bill compared to presently authorized rates due to increased base rates beginning January 1, 2027. This represents the full increase over the next two years.
 - o Residential gas customers can expect a \$7.08 increase on their monthly natural gas bill, compared to presently authorized rates due to increased base rates, assuming average usage of 68 therms per month, beginning January 1, 2026.
 - o Residential gas customers can expect a \$8.70 increase on their monthly natural gas bill, compared to presently authorized rates due to increased base rates, assuming

average usage of 68 therms per month, beginning January 1, 2027. **This represents** the full increase over the next two years.
