## **Mosinee Police Department Investigates Bomb Threat at the Mosinee High School**

On Thursday, 02-01-24 at 11:50am the Marathon County Sheriff's Department dispatch center received information from the "988" crisis hotline regarding a bomb threat at the Mosinee High School located at 1000 High Street. The initial information indicated that there were multiple bombs hidden on the school premises. The Mosinee Police Department immediately contacted the Mosinee School District and advised administrative staff of the threat. The Mosinee Police Department responded to the high school and requested mutual aid from surrounding law enforcement agencies. Law enforcement personnel secured the perimeter of the Mosinee High School, Middle School, and Elementary School.

The Mosinee Police Department in conjunction with the Mosinee School administration placed all three school buildings in a "hold" at 12:06pm to ensure the safety of the students, school staff and citizens. At 12:33pm all three schools began an evacuation of students and staff. Students and staff from the High School and Elementary School were evacuated to the Mosinee Recreation Center. Students and staff from the Middle School were evacuated to St. Paul's Catholic Church. The Mosinee School District notified parents of the status and location of their children. Law enforcement personnel and school staff assisted in the safe reunification of the children with their parents.

Multiple Law Enforcement agencies assisted in securing the scene and conducting a systematic search of the three school structures. Six (6) police dogs trained in the detection of explosives were requested and responded to the scene to assist in the search efforts. Law Enforcement personnel from the following jurisdictions responded to assist in the investigation: Marathon County Sheriff's Department, Kronenwetter Police Department, Rothschild Police Department, Brown County Sheriff's Department, Outagamie County Sheriff's Department, Wood County Sheriff's Department, Wisconsin State Patrol, and the U.W. Madison Police Department. At 6:40pm the search efforts determined that all three school structures were determined to be safe, and no further threat existed. The Mosinee Police Department would like to thank all of the law enforcement officers from these agencies that responded in a timely manner to assist in this investigation.

The Mosinee School District has cancelled classes for tomorrow. The Mosinee Police Department will continue to investigate this incident and any information can be directed to the Mosinee Police Department #715-693-2000.

The Mosinee Police Department would like to extend a thank you to all of the Mosinee school staff, students, and parents for their patience during this investigation.
