COMMERCIAL-INDUSTRIAL TAX ABATEMENT
CITY OF RED OAK, TEXAS**

NOTICE IS HEREBY GIVEN TO INTERESTED PERSONS THAT:

The City Council of the City of Red Oak, Texas (the "City") will consider approval of a Tax Abatement Agreement with H&H Capital Acquisitions, LLC, applicant, for property located in Reinvestment Zone No. 15, in the City of Red Oak, Texas, under the provisions of Chapter 312, Texas Tax Code (the "Act").

The City will consider the Tax Abatement Agreement during its regular meeting to be held at **7:00 p.m. on Monday, May 11, 2026**, in the City Council Chamber in the Red Oak Government Center, 101 S. Live Oak Street, Red Oak, Texas.

The City Council of the City of Red Oak, Texas (the "City") will consider a request concerning that all that land being approximately 886.527± acres of land situated in the following tracts of land:
