Re: Representative Gerald L. Brady / Ethics Committee meeting tomorrow

Dear Ms. Lantz:

This Firm represents Representative Gerald L. Brady in all matters relating to any Ethics Committee accusations against him. I write to you as a staff attorney of the General Assembly regarding the Ethics Committee.

WDEL reported this morning demands on the Committee by one local organization. And I have just received a copy of a two page Joint Statement dated today regarding my client and demanding his expulsion from the General Assembly and the termination of his day job with the DE-AFL-CIO. This is signed by six purported Middle Atlantic organizations.

If there is a matter before the Committee, be advised that Mr. Brady demands that his substantive and procedural Due Process rights be followed regarding any proceedings of the Ethics Committee. He is protected under the U.S. Constitution since his Liberty and Property interests are being attacked. This means written notice of any charges against him, opportunity to prepare a defense, and a disinterested hearing before any adverse decision against him. See Cleveland Board of Education v. Loudermill, 470 U.S. 532, 542 (1985); Mathews v. Eldridge, 424 U.S. 319 (1976).

As we all are aware, out of State organizations are seeking to make prostitution legal in Delaware and they are trying to "cancel" Mr. Brady, who also serves as a State legislator in the House of Representatives, since he opposes their efforts to make prostitution and sex for money legal in our State and no longer a crime, since he also serves on the House Judiciary Committee.

These out of State anonymous actors have joined with others in State to "cancel" Mr. Brady's service as a legislator in the current General Assembly and they seek to have the DE AFL-CIO fire him with the loss of his yearly family income from his long term day job.

Many locally have been duped by these outsiders who are seeking to remove the laws against prostitution. The "pretext" which has been used to remove him from the Judiciary Committee on which he serves was Mr. Brady's unguarded, free speech protected, and private email to a friend, which inadvertently found its way into the hands of those outsiders, who then, after a few weeks of planning their assault, launched the current attacks on Mr. Brady which led to his declaring that at the end of the current General Assembly session in 2022 he will end his political career. He also has taken many steps to apologize and demonstrate remorse for his untimely private remarks.

But that is not enough for those outsiders who are really seeking to send a message to the members of the General Assembly to not oppose their under the radar efforts to legalize prostitution here in Delaware, as they will renew their efforts after Mr. Brady is fully "cancelled."

I respectfully urge caution in any rush to judgment regarding my client and hope that all efforts end to make Mr. Brady suffer any more for his support of traditional morality in opposition to the exploitation of women in the sex trade.
