That during January 25, 2022 thru March 16, 2023, in Bullitt County, Kentucky, the above named defendant, committed the offense of Theft By Deception Over \$10,000 by obtaining property or services from Lindsey Wolff, of a value over \$10,000, by creating or reinforcing a false impression, including false impressions as to law, value, intention, or other state of mind, with intent to deprive Lindsey Wolff thereof.


