For a regular/standard Kentucky Driver's License renewal (through Office of the Circuit Court Clerk), visit any of these branches Monday to Friday, 8 a.m. to 4 p.m.: West Louisville/Nia Center, Southwest, Outer Loop-Highview, Middletown or Bowman Field, OR use MAIL-IN OPTION. (Note: Renew by mail is ONLY for applicants whose driver's license/ID card expired or was lost/stolen between Mar. 1, 2020–Feb. 28, 2021. You may NOT renew by mail if you have an address/name change, if you need a CDL (Commercial Driver's License) renewal or if you require additional testing.

# **For REPLACEMENT of LOST/STOLEN** driver's license, permit or ID, you must present one of the following:

- Social Security Card
- Income tax return
- Loan paperwork
- Lease/rental agreement
- Auto transfer/auto registration
- Court paperwork
- Hunting/fishing license
- Legal contract (i.e., cell phone)
- Hospital release form
- Birth certificate
- Passport
- Military/work/school photo ID

# **FIRST-TIME KENTUCKY IDS** — Necessary documents:

- Birth certificate
- Social Security Card
- Proof of address
- Marriage license (if name is different than on birth certificate)

Under 18-years-old: Must have parent or guardian present to sign

# **OUT-OF-STATE TRANSFERS** — Necessary documents:

- Valid out-of-state license
- Social Security Card or W2 tax form with full SSN
- Proof of Jefferson County address:
   (i.e., deed, property tax bill, lease, utility bill) hard copy; dated within 60 days

 Birth certificate or Passport (If your name has changed, must provide documentation to show name change, i.e, marriage license, divorce decree)
