POST-ARREST COMPLAINT. On September 23, 2020, members of the Louisville Metro Police Dept. (LMPD) were conducting crowd control operations at Broadway and Beak St. LMPD's crowd control operations were in response to a large crowd that had set fires, caused property damage and failed to disperse after being warned. As LMPD members addressed the crowd the listed subject intentionally used a handgun to fire multiple bullets at officers. Two officers with LMPD were struck by the bullets causing serious physical injury. The listed subject was seen by witnesses firing a handgun at officers and running from the scene. When the listed subject was detained he was found in possession of a handgun. Video of the shooting has been recovered and shows the listed subject shooting at officers.

POST-ARREST COMPLAINT Continued from citation/control number MO82062
The firearm recovered from the listed subject and shell casings from the scene were compared by NIBEN. Based on my experience with members of ATF and with firearms examiners, a NIBEN lead is an unconfirmed (presumptive) potential association between two or more pieces of firearm ballistic evidence based on a correlation review of digital images in the NIBEN database. These potential associations are identified by either a firearms examiner or a trained NIBEN technician. There is a high probability that a microscopic comparison by a firearms examiner will confirm the association between the firearms ballistic evidence. On September 23, 2020, trained personnel from the Louisville Metro Police Department Crime Scene Unit identified a NIBEN lead between cartridge cases fired from the listed subject's handgun and shell casings found at the scene.
