E1 was dispatched to a smoke investigation outside. While responding, Safety One located a structure fire in the woods on Mores Blvd.

E1 arrived and caught a Hydrant at the intersection of Bowling St and Mores Blvd. We laid in 4' hose to the fire, and BC1 and Eng. Baxter completed the water supply connection.

I (Eric Wesbury) observed a small structure fully involved. The structure was approximately 100 yards off the road way in the woods, and was surrounded by underbrush. FF Huthman and I deployed a 2.5" hose line and began knocking down the fire. Additional hose lines were deployed by other companies, and the fire was quickly brought under control.

We then transitioned to overhaul, removing metal roofing that had fallen into the structure and was covering burning material. Once removed, we fully extinguished the fire and cooled all remaining hotspots.

Marshall 4 then arrived and performed an investigation. During that time, we returned all hose and equipment to E1.

Command then returned all units to service with exception of E1.

E1 cleared the scene but remained out of service to clean hose and equipment and return the apparatus to an in service state.

Once complete, I placed E1 back in service.

Safety 1 arrived on scene and reported to BCJC the correct location for the call, along with a size up reporting the fire was a working residential structure fire. I asked BCJC to upgrade the call to a RSF. I conducted a 360 of the structure and reported to BCJC a 30x60 structure with no basement fully involved with access issues due to being in the woods. BC1 arrived scene and assumed command. Command assigned me Charlie division on the back side of the structure. I managed safety and Charlie division while crews were operating around the building.

Once the incident was under control, I assisted with loading equipment and getting companies back to service. Command was terminated and all units returned to service.
