Re: Dept. of Justice Homelessness Fraud and Corruption Task Force (Task Force)

Dear U.S. Attorney Essayli and Dept. of Justice officials:

The Westside Regional Alliance of Councils (WRAC) is a cooperative coalition, formed in 2009, of all 14 neighborhood and community councils on the Westside of Los Angeles, located in Council Districts 5 and 11 and portions of Districts 4 and 10 – from Westchester/Playa del Rey to Pacific Palisades, and from Venice to South Robertson. Together, our alliance represents over 500,000 housed and unhoused individuals

WRAC greatly appreciates that the Dept. of Justice, Central District of California, has now formed the Task Force. We have long been disturbed by the growing humanitarian crisis involving homelessness in Los Angeles, and by the reported and evident mismanagement in the use of taxpayer funds for this purpose. On the recommendation of the WRAC Homelessness Committee (HOC), the WRAC Board in turn recently recommended, and WRAC's member councils have passed, motions requesting that the Dept. of Justice and other federal, state, county and city entities conduct investigations into mismanagement and potential fraud in the use of such funds to address homelessness in Los Angeles.

WRAC's member councils and the members of the WRAC HOC consist of community leaders who have years-long, first-hand experience dealing with homelessness matters in their neighborhoods, often working with government and private-sector partners to obtain services (including mental and physical health and addiction assistance, as well as housing/shelter) for the thousands of unhoused individuals who are present throughout the Westside. We are familiar with the serious needs and challenges facing unhoused individuals in Los Angeles. WRAC and its HOC stand ready to assist the Task Force in any way that may be helpful.

In addition, the WRAC HOC respectfully invites you or other knowledgeable officials with the Dept. of Justice, the FBI, the IRS Criminal Division and/or the Dept. of Housing and Urban Development Office of the Inspector

General, to attend the next HOC meeting via Zoom at 7pm on **Tuesday, April 22, 2025**, to discuss the work of the Task Force and whether we can be of any help in this regard.

We would very much appreciate hearing from you at your earliest convenience as to whether you or other officials will be able to attend our online HOC meeting on April 22. We look forward to the discussion!
