(X)OFFICER J. Beldon's REPORT STATES THE FOLLOWING:

On 2-24-22 an anonymous caller called the police department and advised that the defendant and the victim were yelling at one another. The caller also indicated that the defendant possibly bit the victim and broke out a window on a gold Cadillac that was parked in front of policy which is where the defendant and the victim were currently inside at. When I arrived on scene I could still hear the defendant yelling loudly from inside the residence. After contact was eventually made I could clearly see that the victim had very visible injuries to her face which appeared to have been caused by someone's fingernails. The victim

advised that the defendant was physically holding her down and refusing to let her leave the residence., which is how she got the scratches on her face. The defendant has a prior conviction for domestic battery from 6-26-1999 (02D04-9906-CM-004512).
