#### SECOND SUPERSEDING INDICTMENT

#### **COUNT ONE**

#### THE GRAND JURY CHARGES THAT:

1. From in or around June 2017 through March 21, 2018, in Berks County, in the Eastern District of Pennsylvania, and elsewhere, defendants

JESUS FELICIANO-TRINIDAD, a/k/a "Chewy," a/k/a "Che," YOMAR VELAZQUEZ-FIGUEROA a/k/a "Negrito," FITZGERALD DALIOT-RIOS, a/k/a "Barber," MARIELA ALVARADO, a/k/a "Onyx," **DEWAYNE QUINONES,** a/k/a "Hombre," OWEN MALAVE-MEDINA, PEDRO SANCHEZ-LAPORTE, a/k/a "Javi," and LILLIAN GARCIA-ORTIZ, a/k/a "Lilly,"

conspired and agreed, together with G.M., S.M.O., F.L., and R.R., charged elsewhere, and others known and unknown to the Grand Jury, to knowingly and intentionally distribute controlled substances, in violation of Title 21, United States Code, Section 841(a)(1).

2. It is further alleged that, with respect to the conspiracy charged in this Count, 500 grams or more of a mixture and substance containing a detectable amount of methamphetamine, a Schedule II controlled substance, is attributable, and was reasonably foreseeable, to defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, in violation of Title 21, United States Code, Section 841(a)(1), (b)(1)(A).

- 3. It is further alleged that, with respect to the conspiracy charged in this Count, 100 grams or more of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance, is attributable, and was reasonably foreseeable, to defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, MARIELA ALVARADO, DEWAYNE QUINONES, OWEN MALAVE-MEDINA, PEDRO SANCHEZ-LAPORTE, LILLIAN GARCIA-ORTIZ, in violation of Title 21, United States Code, Section 841(a)(1), (b)(1)(B).
- 4. It is further alleged that, with respect to the conspiracy charged in this Count, 500 grams or more of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance, is attributable, and was reasonably foreseeable, to defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, MARIELA ALVARADO, in violation of Title 21, United States Code, Section 841(a)(1), (b)(1)(B).
- 5. It is further alleged that, with respect to the conspiracy charged in this Count, a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance, is attributable, and was reasonably foreseeable, to defendants OWEN MALAVE-MEDINA and PEDRO SANCHEZ-LAPORTE, in violation of Title 21 United States Code, Section 841(a)(1), (b)(1)(C).
- 6. It is further alleged that, with respect to the conspiracy charged in this Count, a mixture and substance containing a detectable amount of cocaine base ("crack"), a Schedule II controlled substance, is attributable, and was reasonably foreseeable, to defendants

JESUS FELICIANO-TRINIDAD, FITZGERALD DALIOT-RIOS, and MARIELA ALVARADO, in violation of Title 21, United States Code, Section 841(a)(1), (b)(1)(C).

#### MANNER AND MEANS

It was part of the conspiracy that:

- 5. Defendant JESUS FELICIANO-TRINIDAD was the leader and organizer of a drug trafficking group (hereinafter "the Trinidad DTG") that obtained distribution quantities of methamphetamine, heroin, fentanyl, cocaine, cocaine base ("crack"), synthetic cannabinoids and other controlled substances from suppliers, including from F.L., both outside and within the Eastern District of Pennsylvania. From in or around June 2017 through March 21, 2018, the Trinidad DTG distributed in excess of 500 grams of methamphetamine, 100 grams of heroin, 500 grams of cocaine, and quantities of crack cocaine and other controlled substances.
- 6. Defendant JESUS FELICIANO-TRINIDAD and others known and unknown to the Grand Jury, supplied methamphetamine, heroin, cocaine, crack cocaine and other controlled substances to other members of the Trinidad DTG, including defendants YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, MARIELA ALVARADO, DEWAYNE QUINONES, OWEN MALAVE-MEDINA, PEDRO SANCHEZ-LAPORTE, LILLIAN GARCIA-ORTIZ for redistribution to individual drug customers.
- 7. Defendant LILLIAN GARCIA-ORTIZ and S.M.O. and others known to the Grand Jury facilitated the distribution of drugs to defendant JESUS FELICIANO-TRINIDAD, who then delivered the drugs to other members of the Trinidad DTG both known and unknown to the Grand Jury, for redistribution.

- 8. In the summer 2017, S.M.O. introduced F.L. as a source of drug supply to defendants JESUS FELICIANO-TRINIDAD and PEDRO SANCHEZ-LAPORTE. S.M.O. acted as a conduit of drug supply between F.L. and defendants FELICIANO-TRINIDAD and SANCHEZ-LAPORTE.
- 9. Defendant FITZGERALD DALIOT-RIOS, and G.M., and others known and unknown to the Grand Jury repackaged the bulk drugs for defendant JESUS FELICIANO-TRINIDAD and the Trinidad DTG for redistribution from 34 South 11<sup>th</sup> Street, 304 South 6<sup>th</sup> Street, and other known and unknown locations in Reading, Pennsylvania for street sales to drug customers both known and unknown to the Grand Jury.
- 10. Members of the Trinidad DTG routinely utilized telephones and various forms of electronic social media to communicate about the drug trafficking and violent activities of the Trinidad DTG.
- 11. Members of the Trinidad DTG routinely utilized firearms and acts of violence in furtherance of the organization's drug trafficking activities.
- 12. Members of the Trinidad DTG used various residences as "stash houses" to store, process, and package controlled substances, and various residences as "distribution houses" to distribute sums of controlled substances, in the Reading, Pennsylvania area, including but not limited to:
  - a. 318 Wood Street,
  - b. 329 Lombard Street,
  - c. 2188 D Elder Street,
  - d. 34 South 11th Street,

- e. 329 Constitution Way,
- f. 333 Constitution Way,
- g. 304 South 6<sup>th</sup> Street,
- h. 800 Franklin Street, 1st Floor,
- i. 123 S. 3<sup>rd</sup> Street, and
- j. 837 Muhlenberg Street.

#### **OVERT ACTS**

In furtherance of the conspiracy, and to accomplish its objectives, the defendants and others known and unknown to the Grand Jury committed the following overt acts, among others, in the Eastern District of Pennsylvania and elsewhere:

- 1. On or about June 8, 2017, defendant MARIELA ALVARADO distributed approximately .07 grams of cocaine base ("crack"), a Schedule II controlled substance, to an Undercover Police Officer (the "UC"), a person known to the Grand Jury, who was acting at the direction of law enforcement.
- 2. On or about June 13, 2017, defendant MARIELA ALVARADO distributed approximately .03 grams of cocaine base ("crack"), a Schedule II controlled substance to the UC.
- 3. On or about June 15, 2017, defendant MARIELA ALVARADO distributed approximately .04 grams of cocaine base ("crack"), a Schedule II controlled substance to the UC.

- 4. On or about June 26, 2017, defendant MARIELA ALVARADO distributed approximately 7 grams of synthetic cannabinoid (indole carboxamide), a Schedule I controlled substance to the UC.
- 5. In or about August 2017 through March 21, 2018, defendant JESUS FELICIANO-TRINIDAD received methamphetamine, heroin, and cocaine from F.L., and then defendant FELICIANO-TRINIDAD and members of the Trinidad DTG redistributed the drugs in user quantities to persons known and unknown to the Grand Jury.
- 6. In or about August 2017, defendant PEDRO SANCHEZ-LAPORTE received heroin and cocaine from F.L., and then defendant SANCHEZ-LAPORTE and members of the Trinidad DTG redistributed the drugs in user quantities to persons known and unknown to the Grand Jury.
- 7. On or about December 13, 2017, defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, and others known and unknown to the Grand Jury shot and killed Miguel Reyes, in order to expand the drug distribution territory for the Trinidad DTG.
- 8. On or about January 21, 2018, defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, L.D. (deceased), and J.C.G. (charged elsewhere), and others known and unknown to the Grand Jury, including Angel Rivera-Silva and Mayco Alvarez-Jackson, kidnapped Hector Gonzalez-Rivera a/k/a/ "Pollito," after Gonzalez-Rivera failed to follow defendant FELICIANO-TRINIDAD's instructions to shoot at a rival drug trafficker and failed to return the firearm that defendant FELICIANO-TRINIDAD had provided him for the shooting.

- 9. Between on or about January 21, 2018 and on or about January 24, 2018, defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, L.D. (deceased), and J.C.G. (charged elsewhere), and others known and unknown to the Grand Jury, including Mayco Alvarez-Jackson, held Hector Gonzalez-Rivera in the basement of 34 S. 11<sup>th</sup> Street in Reading, Pennsylvania and assaulted and starved him.
- 10. On or about January 24, 2018, defendant JESUS FELICIANO-TRINIDAD directed defendants YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, L.D. (deceased), and others known and unknown to the Grand Jury, to kill Hector Gonzalez-Rivera, a/k/a "Pollito." Specifically, defendant FELICIANO-TRINIDAD directed that Gonzalez Rivera be killed by drug overdose injection and then if necessary by gunshot in order to send a message that Gonzalez Rivera failed to follow defendant FELICIANO-TRINIDAD's orders and stole his firearm.
- 11. On or about January 28, 2018, defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, DEWAYNE QUINONES, PEDRO SANCHEZ-LAPORTE, and others known and unknown to the Grand Jury, including Mayco Alvarez-Jackson, shot and killed Jarlyn Lantigua-Tejada, Juan Rodriguez, Nelson Onofre, and Joshua Santos in order to expand the drug distribution territory for the Trinidad DTG.
- 12. On or about February 3, 2018, defendant JESUS FELICIANO-TRINIDAD distributed approximately 13 grams of cocaine, a Schedule II controlled substance, to a confidential human source ("CS"), a person known and unknown to the Grand Jury, who was acting at the direction of law enforcement.

- 13. On or about February 16, 2018, defendant JESUS FELICIANO-TRINIDAD distributed approximately 13 grams of cocaine, a Schedule II controlled substance, to the CS.
- 14. On or about February 17, 2018, defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, DEWAYNE QUINONES, R.R. (charged elsewhere), J.D., and J.A.V., who are known to the Grand Jury, drove to a residence on the 1100 block of Marion Street in Reading, Pennsylvania, used by rival drug trafficker R.S., and fired multiple gunshots at the residence.

On or about February 25, 2018:

- 15. Defendant JESUS FELICIANO-TRINIDAD asked F.L., a person known to the Grand Jury, to give him 50 grams of cocaine, stating, "I need 50 to cook I'm dry at the spot I have the ticket," to which F.L. responded, "Ok give me a few."
- 16. Defendant JESUS FELICIANO-TRINIDAD contacted defendant FITZGERALD DALIOT-RIOS by cell phone and directed defendant DALIOT-RIOS to bring him the items he needed to convert cocaine into cocaine base. In that same conversation, defendant FELICIANO-TRINIDAD also directed defendant YOMAR VELAZQUEZ-FIGUEROA to bring drug proceeds to defendant FELICIANO-TRINIDAD.
- 17. F.L. subsequently delivered the 50 grams of cocaine to defendant JESUS FELICIANO-TRINIDAD.
- 18. F.L. also contacted defendant JESUS FELICIANO-TRINIDAD asking where defendant FELICIANO-TRINIDAD was in order to deliver 50 grams of heroin.

- 19. Defendant JESUS FELICIANO-TRINIDAD directed F.L. to deliver the heroin to 318 Wood Street and give it to "her," defendant LILLIAN GARCIA-ORTIZ.
- 20. Defendant JESUS FELICIANO-TRINIDAD informed defendant FITZGERALD DALIOT-RIOS to tell defendant YOMAR VELAZQUEZ-FIGUEROA to deliver drug proceeds to 318 Wood Street and give it to defendant LILLIAN GARCIA-ORTIZ, stating, "send [defendant VELAZQUEZ-FIGUEROA] over there. When he gets there tell him to call me. So I can send Lilly [defendant LILLIAN GARCIA-ORTIZ] to open the girl."
- 21. Defendants JESUS FELICIANO-TRINIDAD, FITZGERALD DALIOT-RIOS, YOMAR VELAZQUEZ FIGUEROA, DEWAYNE QUINONES, R.R. and E.O., who are known to the Grand Jury, discussed plans to shoot and murder a rival drug trafficker R.S.

On or about February 26, 2018:

- 22. Defendants JESUS FELICIANO-TRINIDAD, FITZGERALD DALIOT-RIOS, YOMAR VELAZQUEZ FIGUEROA, DEWAYNE QUINONES, R.R., J.F.R. and V.V.T., who are known to the Grand Jury, attempted to find a rival drug trafficker named D.R., who is known to the Grand Jury, in order to shoot and murder D.R.
- 23. Defendants JESUS FELICIANO- TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, and S.M.O. distributed approximately 55 grams of methamphetamine, a Schedule II controlled substance, to the CS.
- 24. On or about February 27, 2018, defendants JESUS FELICIANO-TRINIDAD, DEWAYNE QUINONES, FITZGERALD DALIOT-RIOS, YOMAR VELAZQUEZ-FIGUEROA, S.M.O., F.L., and K.R. agreed to kidnap R.G.E., a person known to the Grand Jury, assault him and force him to pay his drug debts.

On or about March 3, 2018:

- 25. Defendant JESUS FELICIANO-TRINIDAD contacted defendant FITZGERALD DALIOT-RIOS and directed him to prepare 3 grams of heroin for M.V.M., a person known to the Grand Jury.
- 26. Defendant FITZGERALD DALIOT-RIOS subsequently delivered 3 grams of heroin to M.V.M.
- 27. On or about March 6, 2018, defendants JESUS FELICIANO-TRINIDAD and YOMAR VELAZQUEZ-FIGUEROA, distributed approximately 5 grams of heroin, a Schedule I controlled substance, and approximately 27 grams of methamphetamine, a Schedule II controlled substance, to the CS.

On or about March 7, 2018:

- 28. Defendant JESUS FELICIANO-TRINIDAD directed G.M. to package a quantity of heroin for distribution.
- 29. Defendant JESUS FELICIANO-TRINIDAD directed defendants

  FITZGERALD DALIOT-RIOS and YOMAR VELAZQUEZ-FIGUEROA to provide 30 grams of heroin to G.M.
- 30. Defendant YOMAR VELAZQUEZ-FIGUEROA provided heroin to G.M. intended for repacking and subsequent redistribution by the Trinidad DTG.

On or about March 13, 2018:

31. Defendants JESUS FELICIANO-TRINIDAD, MARIELA ALVARADO, FITZGERALD DALIOT-RIOS distributed approximately .5 grams of cocaine base ("crack"), a Schedule II controlled substance to the CS.

- 32. Defendant JESUS FELICIANO-TRINIDAD contacted F.L. for 100 grams of heroin.
- 33. F.L. delivered the 100 grams of heroin to defendant JESUS FELICIANO-TRINIDAD. Defendant FELICIANO-TRINIDAD then gave it to defendant DEWAYNE QUINONES.
- 34. Defendant DEWAYNE QUINONES then delivered the 100 grams of heroin to G.M. for her to process into user quantity amounts for street sales for the Trinidad DTG.
- 35. In a telephone conversation, defendant JESUS FELICIANO-TRINIDAD, and G.M. discussed the heroin that G.M. was breaking down into user quantities.
- 36. On or about March 16, 2018, defendants JESUS FELICIANO-TRINIDAD and MARIELA ALVARADO, distributed 50 bags (approximately .79 grams) of heroin, a Schedule I controlled substance to the CS.

On or about March 21, 2018:

possessed heroin, a mixture of heroin and fentanyl, synthetic cannabinoids, a ballistic vest, a green .223/5.56 mm pistol, with no serial number, with an attached 50-round drum magazine that was loaded with 48 live rounds of .223 caliber ammunition, a Colt .38 caliber revolver, bearing serial number 829256, 202 live rounds of Winchester .40 caliber ammunition, 126 live rounds of 9 mm ammunition, two 9mm XD9 magazines, one loaded with 7 live rounds, the other with 8 live rounds, 28 live rounds of .45 caliber ammunition, and approximately 28 cellular telephones.

38. Defendants YOMAR VELAZQUEZ-FIGUEROA and OWEN MALAVE-MEDINA possessed heroin, cocaine, synthetic cannabinoids, a Galena Industries/AMT .45 caliber semiautomatic pistol, bearing serial number GBA01247 that was loaded with 4 live rounds of ammunition, a Springfield XD40 .40 caliber pistol, bearing serial number US418088 that was loaded with 11 live rounds of ammunition, 7 cellular telephones, a digital scale, processing equipment for drugs, records of drug sales, and \$515 cash.

All in violation of Title 21, United States Code, Section 846.

On or about June 8, 2017, in Berks County, in the Eastern District of Pennsylvania, defendant

knowingly and intentionally distributed a mixture and substance containing a detectable amount of cocaine base ("crack"), a Schedule II controlled substance.

## **COUNT THREE**

## THE GRAND JURY FURTHER CHARGES THAT:

On or about June 13, 2017, in Berks County, in the Eastern District of Pennsylvania, defendant

# MARIELA ALVARADO, a/k/a "Onyx,"

knowingly and intentionally distributed a mixture and substance containing a detectable amount of cocaine base ("crack"), a Schedule II controlled substance.

## **COUNT FOUR**

## THE GRAND JURY FURTHER CHARGES THAT:

On or about June 15, 2017, in Berks County, in the Eastern District of Pennsylvania, defendant

# MARIELA ALVARADO, a/k/a "Onyx,"

knowingly and intentionally distributed a mixture and substance containing a detectable amount of cocaine base ("crack"), a Schedule II controlled substance.

#### **COUNT FIVE**

#### THE GRAND JURY FURTHER CHARGES THAT:

From on or about January 21, 2018, through on or about January 24, 2018, in
 Berks County, in the Eastern District of Pennsylvania, and elsewhere, defendants

JESUS FELICIANO-TRINIDAD,
a/k/a "Chewy,"
a/k/a "Che,"
YOMAR VELAZQUEZ-FIGUEROA
a/k/a "Negrito,"
FITZGERALD DALIOT-RIOS,
a/k/a "Barber,"
ANGEL RIVERA-SILVA,
a/k/a "Estrellita," and
MAYCO ALVAREZ-JACKSON,
a/k/a "Pipon,"

conspired and agreed with L.D., deceased, J.C.G., charged elsewhere, and others known and unknown to the Grand Jury, to knowingly, willfully, and unlawfully seize, confine, kidnap, abduct, carry away, and hold, Hector Gonzalez-Rivera, a/k/a "Pollito," deceased, for ransom, reward, and otherwise, that is, for the purpose of punishing Gonzalez Rivera, a person known to the Grand Jury, for failing to follow defendant JESUS FELICIANO-TRINIDAD's instructions to shoot at a rival drug trafficker's residence and for failing to return defendant FELICIANO-TRINIDAD's firearm, resulting in the death of Gonzalez Rivera, and, in committing the offense used a means, facility, and instrumentality of interstate commerce, that is, a mobile telephone, in violation of Title 18, United States Code, Section 1201(a)(1).

#### **MANNER AND MEANS**

It was part of the conspiracy that:

2. Defendant JESUS FELICIANO-TRINIDAD and the Trinidad DTG routinely

used violence to intimidate rival drug traffickers in order to ensure the success of the Trinidad DTG operating in Reading, Pennsylvania.

- 3. Defendant JESUS FELICIANO-TRINIDAD directed Hector Gonzalez Rivera to shoot at a rival drug trafficker's residence located in Reading, Pennsylvania and defendant FELICIANO-TRINIDAD provided Gonzalez Rivera with a firearm.
- 4. After Hector Gonzalez-Rivera failed to follow defendant JESUS FELICIANO-TRINIDAD's instructions to shoot at a rival drug trafficker's residence and failed to return the firearm that defendant FELICIANO-TRINIDAD provided for the shooting, defendants FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, ANGEL RIVERA-SILVA, MAYCO ALVAREZ-JACKSON, L.D. (deceased), and J.C.G. (charged elsewhere), and persons known and unknown to the Grand Jury agreed to kidnap Hector Gonzalez-Rivera.
- 5. Defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, ANGEL RIVERA-SILVA, MAYCO ALVAREZ-JACKSON used a communication facility and an instrumentality of interstate commerce, that is, a mobile telephone to effectuate this agreement.

#### **OVERT ACTS**

In furtherance of the conspiracy and to affect the object of the conspiracy, defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, ANGEL RIVERA-SILVA, MAYCO ALVAREZ-JACKSON, and others known and unknown to the Grand Jury committed the following overt acts, among others, in the Eastern District of Pennsylvania and elsewhere:

On or about January 21, 2018:

- 1. Defendant JESUS FELICIANO-TRINIDAD, in Reading, Pennsylvania communicated with defendant ANGEL RIVERA-SILVA, by mobile telephone, and defendant RIVERA-SILVA stated that Hector Gonzalez-Rivera was in defendant RIVERA-SILVA's vehicle and that defendant RIVERA-SILVA would bring Gonzalez Rivera to an agreed upon location to meet with defendant FELICIANO-TRINIDAD and his DTG associates.
- 2. Defendants JESUS FELICIANO-TRINIDAD and MAYCO ALVAREZ-JACKSON drove to a parking lot in Reading, Pennsylvania to meet defendant ANGEL RIVERA-SILVA and Hector Gonzalez-Rivera.
- 3. Upon arrival at the location, defendants JESUS FELICIANO-TRINIDAD and MAYCO ALVAREZ-JACKSON assaulted Hector Gonzalez-Rivera, and then kidnapped and transported him to a Trinidad DTG drug house located at 34 South 11<sup>th</sup> Street, in Reading, Pennsylvania, which was operated by defendant FITZGERALD DALIOT-RIOS.
- 4. Defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, and MAYCO ALVAREZ-JACKSON forced Hector Gonzalez-Rivera into the basement.
- 5. Defendants JESUS FELICIANO-TRINIDAD, MAYCO ALVAREZ-JACKSON, and others known and unknown to the Grand Jury, assaulted Hector Gonzalez-Rivera by hitting Gonzalez Rivera with their fists and a piece of wood while Gonzalez Rivera was held against his will in the basement.
- 6. Defendants JESUS FELICIANO-TRINIDAD, YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, and L.D. held Hector Gonzalez-Rivera, in the

basement for several days providing Gonzalez Rivera with little food or water.

On or about January 24, 2018:

- 7. Defendant JESUS FELICIANO-TRINIDAD ordered defendants YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, and L.D. to kill Hector Gonzalez-Rivera by injecting Gonzalez Rivera with a fatal drug overdose or if necessary by shooting him.
- 8. Defendants YOMAR VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, and L.D. injected Hector Gonzalez-Rivera with drugs in an attempt to cause a drug fatal overdose, however, when that failed to kill Gonzalez Rivera, defendants VELAZQUEZ-FIGUEROA, FITZGERALD DALIOT-RIOS, and L.D. forced Gonzalez Rivera to an alley and shot him in the head.

All in violation of Title 18, United States Code, Section 1201(c).

- 3. When R.G.E. did not make prompt payment in full, defendants JESUS FELICIANO-TRINIDAD, DEWAYNE QUINONES, FITZGERALD DALIOT-RIOS, YOMAR VELAZQUEZ-FIGUEROA, F.L., S.M.O., K.R. and L.D., agreed to kidnap R.G.E. assault him, and force him to pay his drug debt.

- 2. F.L. then informed S.M.O of the whereabouts of R.G.E to help facilitate the kidnapping and assault of R.G.E.

- 3. S.M.O. contacted defendant JESUS FELICIANO-TRINIDAD by telephone and provided defendant FELICIANO-TRINIDAD the information regarding the whereabouts of R.G.E.
